The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided you make the following changes:

Add the following statements after the general misuse statement ("It is a violation of 1. Federal law ...") at the beginning of the Directions for Use:

"Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your state or tribe, consult the agency responsible for pesticide regulation."

On page 4, in the Non-Agricultural Use Requirements box, revise the "Entry Restrictions 2. for Non-WPS Uses" to read as follows:

"For applications on non-crop areas and wildlife openings, do not allow worker entry into treated areas until sprays have dried, unless applicator and other handler PPE is worn." [The word "treated" is missing from the draft labels.]

Correct the typographical error in the Spanish language warning on the front panel: Separate the words "en" and "detalle".

Non-Agricultural Use Requirements

The requirements in this box apply to uses of this product that are NOT within the scope of the Worker Protection Standard for agricultural pesticides (40 CFR Part 170). The WPS applies when this product is used to produce agricultural plants on farms,

Entry Restrictions for Non-WPS Uses: For applications on non-crop areas and wildlife openings, do not allow worker entry into forests, nurseries or greenhouses. areas until sprays have dried, unless applicator and other handler PPE is worn.

Toram 101 weed and brush herbicide is recommended for control of unwanted annual and perennial broadleaf weeds and woody plants and vines on forest planting sites and non-crop areas including industrial manufacturing and storage sites, rights-of-way, such as electrical power lines, communication lines, pipelines, highways, railroads and wildlife openings in forest and non-crop areas.

Use Toram 101 weed and brush herbicide at rates of ½ to 2 gallons per acre to control broadleaf weeds and at rates of 1 to 2 gallons Ose rorant. To riveed and prostinctorde acrates of 72 to 2 gallons per acre to control weeds and acrates of 7 to 2 gallons per acre to control woody plants and vines. Toram 101 may be tank mixed with Garlon 4 or Garlon 3A herbicides, or 4 lbs./gal. 2,4 D low-volatile esters registered for sites listed on this label to control mixed woody plant and vine species. When tank mixing, observe all precautions, directions and limitations on both products' labeling. In all cases use the amounts specified in enough water to give thorough and uniform coverage of the plants to be controlled.

Note: Toram 101 does not readily mix with oil. Use of a non-ionic agricultural surfactant, such as Ortho X-77. Triton AG-98 c Tronic, is recommended for all applications. When using surfactants, follow the use directions and precautions listed on the surfactar manufacturer's label. Use the higher recommended concentrations of surfactant in the spray mixture when applying lower spray volumes per acre.

General Use Precautions and Restrictions

Use this product only as specified on this label. Observe any special use and application restrictions and limitations, including metho of application and permissible areas of use as promulgated by state authorities.

Maximum Use Rates: Total use of Toram® 101 must not exceed 8 quarts per acre per annual growing season on rights-of-way ar other non-crop areas. No more than 8 quarts per acre may be applied within a period of 2 annual growing seasons on forest sites.

Chemigation: Do not apply this product through any type of irrigation system.

Be sure that use of this product conforms to all applicable regulations.

Do not make application when circumstances favor movement from treatment site.

Do not rotate food or feed crops on treated land if they are not registered for use with pictoram until an adequately sensitive bloass or chemical test shows that no detectable picloram is present in the soil.

Do not move treated soil to other areas or use it to grow plants if they are not registered for use with picloram until an adequa sensitive bloassay or chemical test shows that no detectable picloram is present in the soil.

Do not spray if the loss of legumes cannot be tolerated. Toram 101 may injure or kill legumes. New legume seedlings may grow within 2 years following application of this herbicide.

Do not transfer livestock from treated grazing areas onto sensitive broadleaf crop areas without first allowing 7 days of grazing on untreated grass pasture. Otherwise, urine may contain enough pictoram to cause injury to sensitive broadleaf plants.

Do not use manure from animals grazing treated areas on land used for growing broadleaf crops, ornamentals, orchards or o susceptible, desirable plants. Manure may contain enough pictoram to cause injury to susceptible plants.

Do not use plant material from treated areas for composting or mulching of susceptible broadleaf plants.

Do not contaminate water intended for irrigation or domestic purposes. To avoid injury to crops or other desirable plants, do treat or allow spray drift or run-off to fall onto banks or bottoms of irrigation ditches, either dry or containing water, or other channels carry water that may be used for irrigation or domestic purposes. Do not apply to snow or frozen ground.

Do not apply or otherwise permit Toram® 101 or sprays containing Toram® 101 to contact crops or other desirable broad plants including, but not limited to, alfalfa, beans, cotton, grapes, melons, peas, potatoes, safflower, soybeans, sugar beets, sunfic tobacco, tomatoes and other vegetable crops, flowers, fruit plants, ornamentals or shade trees.

Do not apply Toram 101 on residential or commercial lawns or near ornamental trees and shrubs. Untreated trees occasionally be affected by root uptake of herbicide through movement into the topsoil or by excretion of the product from the roc nearby treated trees. Do not apply Toram® 101 within the root zone of desirable trees unless such injury can be tolerated.

injured if planted sooner than 8 to 9 months after treatment. For all conifers, the waiting period between treatment and planting should be 11 to 12 months in the area between the Cascade and Rocky Mountains and 8 to 9 months in the take states and Northeastern U.S.

Avoid injurious spray drift. Applications should be made only when there is little or no hazard from spray drift. Very small quantities of spray, which may not be visible, may seriously injure susceptible crops or ornamental plants near enough to be injured. It is suggested that a continuous smoke column at or near the spray site or a smoke generator on the spray equipment be used to detect air movement, lapse conditions or temperature inversions (stable air). If the smoke layers or indicates a potential of hazardous spray drift, do not spray.

Aerial Application: Avoid spray drift at the application site. The interaction of many equipment- and weather-related factors determine the potential for spray drift. Users are responsible for considering all these factors when making decisions. The following drift management requirements must be followed to avoid off-target drift movement from aerial applications to agricultural field crops:

The distance of the outer most operating nozzles on the boom must not exceed % the length of the wingspan or rotor.

Nozzles must always point backward parallel with the air stream and never be pointed downwards more than 45 degrees.

Where states have more stringent regulations, they should be observed. The applicator should be familiar with and take into account the information covered in the Aerial Drift Reduction Advisory below.

For aerial application on rights-of-way or other areas near susceptible crops, use Nalco-Trol[®] drift control additive as recommended by the manufacturer or apply the Microfoil® or Thru-Valve® boom or use an equivalent drift control system. Thickened sprays prepared by using high viscosity invert systems, or other drift control additives or systems, may be utilized if drift control is comparable to the obtained with Nalco-Trol® or the Microfoil® or Thru-Valve® boom. If a spray-thickening agent is used, follow all use recommendation. and precautions on the product label. Do not use a thickening agent with the Microfoil boom, or other systems that canno accommodate thick sprays.

With aircraft, drift can be lessened by applying a coarse spray; by using spray pressures no greater than are required to obtain adequate plant coverage; by using straight stream nozzles directed straight back; by spraying only when wind velocities are low; or b using an approved drift control system.

Ground Equipment: To aid in reducing spray drift, Toram 101 should be used in thickened (high viscosity) spray mixtures usin Nalco-Trol® drift control additive or equivalent as directed by the manufacturer. With ground equipment, spray drift can be reduced by keeping the spray boom as low as possible; by applying 20 gallons or more of spray per acre; by using spray pressures no greater tha are required to obtain adequate plant coverage; and by spraying when wind velocity is low. Do not apply with hollow cone-typ insecticide or other nozzles that produce a fine droplet spray.

High Volume Leaf-Stem Treatment: Spray drift may be minimized by using spray pressures no greater than are required to obtain adequate plant coverage and spraying no higher than brush tops. Avoid excessive pressures which result in formation of fine spraying mists. Nalco-Trol® thickening agent or equivalent may be used to reduce spray drift. Do not apply this product through a mist blower.

Aerial Drift Reduction Advisory

Information on Droplet Size. The most effective way to reduce drift potential is to apply large droplets. The best drift manageme strategy is to apply the largest droplets that provide sufficient coverage and control. Applying larger droplets reduces drift potential, b will not prevent drift if applications are made improperly or under unfavorable environmental conditions (see Wind, Temperature at Humidity and Temperature Inversions).

- Volume: Use high flow rate nozzles to apply the highest practical spray volume. Nozzles with higher rated flows produce larg Controlling Droplet Size:
- Pressure: Do not exceed the nozzle manufacturer's recommended pressures. For many nozzle types lower pressure produclarger droplets. When higher flow rates are needed, use higher flow rate nozzles instead of increasing pressure.

Number of Nozzles: Use the minimum number of nozzles that provide uniform coverage.

- Nozzle Orientation: Orienting nozzles so that the spray is released parallel to the air stream produces larger droplets than other orientations and is the recommended practice. Significant deflection from horizontal will reduce droplet size and increase d
- Nozzle Type: Use a nozzle type that is designed for the intended application. With most nozzle types, narrower spray angl produce larger droplets. Consider using low-drift nozzles. Solid stream nozzles oriented straight back produce the largest drople

Boom Length: For some use patterns, reducing the effective boom length to less than ¾ of the wingspan or rotor length may furth

Application Height: Applications should not be made at a height greater than 10 feet above the top of the largest plants unless greater height is required for aircraft safety. Making applications at the lowest height that is safe reduces exposure of droplets

Swath Adjustment: When applications are made with a crosswind, the swath will be displaced downward. Therefore, on the up a downwind edges of the field, the applicator must compensate for this displacement by adjusting the path of the aircraft upwind. Sw adjustment distance should increase, with increasing drift potential (higher wind, smaller drops, etc.).

Wind: Drift potential is lowest between wind speeds of 2-10 mph. However, many factors, including droplet size and equipment ty determine drift potential at any given speed. Application should be avoided below 2 mph due to variable wind direction and h states and a local terrain can influence wind patterns. Every applicator should be familiar with local wind patterns a

Temperature and Humidity: When making applications in low relative humidity, set up equipment to produce larger droplets to compensate for evaporation. Droplet evaporation is most severe when conditions are both hot and dry.

Temperature Inversions: Applications should not occur during a local, low-level temperature inversion because drift potential is high. Temperature inversions restrict vertical air mixing, which causes small suspended droplets to remain in a concentrated cloud. This cloud can move in unpredictable directions due to the light variable winds common during inversions. Temperature inversions are characterized by increasing temperatures with altitude and are common on nights with limited cloud cover and light to no wind. They begin to form as the sun sets and often continue into the morning. Their presence can be indicated by ground fog; however, if fog is not present, inversions can also be identified by the movement of the smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

Sensitive Areas: The pesticide should only be applied when the potential for drift to adjacent sensitive areas (e.g. residential areas bodies of water, known habitat for threatened or endangered species, non-target crops) is minimal (e.g. when wind is blowing away from the sensitive areas).

Specific Application Directions

High Volume Leaf-Stem Treatment

Use Toram 101 at the rate of 1 gallon in water to make 100 gallons of spray to control broadleaf weeds, vines and other woody plant) To control a wider range of plant species, mix 1/2 to 1/2 gallon of Toram 101 with 1 to 3 quarts of Garlon 4 herbicide or 1 to 4 quarts Garlon 3A Herbicide or 4 lbs./gal. 2,4-D low-volatile ester and dilute to make 100 gallons of spray. Apply after the foliage is we developed and in a manner to give thorough spray coverage. For woody plants, apply the spray mixture in a manner which thorough wets all leaves, stems and root collars. For had-to-kill species, such as ash and oak, also wet the soil around the root collar. The amount of spray mixture applied per acre will vary with plant size and density; however, total use of Toram® 101 must not exceed quarts per acre. Note: Do not allow the spray, even as minute amounts of spray drift, to contact desirable broadleaf plants, and do n wet the soil over roots of such plants.

Broadcast Ground or Aerial Foliage Treatment

To obtain adequate plant coverage, it is recommended that ground applications of Toram 101 be made in 15 or more gallons of to spray mixture per acre. For aerial applications, use of 5 to 20 gallons per acre of spray mixture is recommended. Use higher spri volumes where plants are tall, where the vegetation to be treated is dense or where difficult to control species are present.

Broadleaf Annual and Perennial Weed and Woody Vine Control: Use Toram® 101 weed and brush herbicide at rates of 2 quarts 2 gallons per acre in a water spray mixture. Apply to problem weeds and vines any time after growth begins in the spring and late

For season control of vigorously growing stands of field bindweed, Canada thistle or mixtures of these with susceptible annual wee such as ragweed, dandelion, plantain, clovers and dock use 2 to 3 quarts of Toram 101 per acre in water spray.

In arid areas and for control of more resistant perennial weeds use 1 to 2 gallons of Toram® 101 per acre. Use 1 to 1½ gallons of acre to control species such as Canada thistle, field bindweed and milkweed. The higher rates should be used under drought stre conditions and for the more resistant species such as bouncingbet, leafy spurge, toadflax and woody vines. The spectrum of activ can be improved by tank mixing ½ to 1 gallon of Toram 101 with 1/3 to 1 gallon of Garlon 3A or 1 to 3 quarts of Garlon 4 per acre. Woody Plant Control: Use Toram 101 at the rate of 1 to 2 gallons per acre in a water spray mixture.

For susceptible seedling stages of species such as aspen, cherry and sumac use 1 to 1½ gallons of Toram 101 per acre in a wa
