Kimble Crangle: Kimball joined DHA in 2008 and currently serves as a Senior Developer, acting as the Project Manager for the Mariposa Redevelopment. On any given day Kimball is meeting with key project stakeholders, active in the entitlement process, reviewing design and construction solutions with consultants or leading the effort on legal and financing closings for Mariposa. Mariposa is garnering national attention for high standards and success in sustainable construction, healthy living and a design-integrated approach to community outreach. The Mariposa redevelopment effort currently has: 193 new-construction units completed and occupied, 164 units under construction and 94 units under design. Financial planning of the second half of the redevelopment began in mid 2013 and is expected to be fully built out by 2018.

Stacey Eriksen: Stacey Eriksen has been an employee of the Environmental Protection Agency for 21 years. Currently she works on sustainable development, HUD/DOT/EPA partnership, LID/GI, Urban Waters, brownfields and urban agriculture. She has previously worked in a number of programs at EPA including, Enforcement, Community-Based Environmental Protection, Superfund, and Hazardous Waste. Stacey spent 4 years on loan from EPA to the City and County of Denver as their Brownfields Coordinator. She also worked on water quality, sustainable development, and affordable green housing issues for the City as part of Greenprint Denver. Prior to EPA, Stacey worked for 3 years for the Department of Energy at Rocky Flats on waste management and environmental remediation issues. Stacey is a Colorado native with a BS in Chemical Engineering from Colorado State University and a MS in Ecological Engineering from Colorado School of Mines. She is also a graduate of the Denver Community Leadership Forum and the Coaches Training Institute.

Cindy Everett: Cindy Everett is a Senior Associate with Urban Land Conservancy (ULC) and is a part of the Real Estate Team which supports the strategic acquisition of land and buildings to create or preserve sustainable benefits in under-served communities. Cindy is actively engaged in the acquisitions, due diligence and development of ULC opportunities and assets. She has led ULC efforts on multiple Targeted Brownfield Assessments and Voluntary Cleanup Plans utilizing various tools and programs provided through local municipalities, Colorado Department of Public Health and Environment, Colorado Brownfields Foundation, the Environmental Protection Agency, and many other supportive organizations. Cindy's education is focused in the field of Community Development and Land Use Planning with an emphasis on affordable housing.
