



## **Executive Summary**

This report represents the Department of Health and Human Services (DHHS) Underground Storage Tank (UST) Compliance report submission. This report meets the Federal Facilities reporting requirements of Public Law 109-58, sections 1521-1533, Underground Storage Tank Compliance Act.

Environmental Protection Agency guidance identifies 11 separate tables that constitute the complete report submission. The information below provides a brief summary of the information contained in these tables.

**Owned / Operated.** The DHHS currently owns and/or operates 66 Underground Storage Tanks. Of these, 63 are both owned and operated by the DHHS, 2 are owned by the DHHS but operated by another entity, and 1 is operated by DHHS but owned by another agency. Tables 1, 2, 3, and 4 provide information about Ownership and Operator responsibilities for each tank in the DHHS inventory.

**Inspections.** Of these 66 tanks, 24 have undergone official inspection by a federal, state, or local regulator and 42 have not. Table #5 provides specific inspection information for each tank.

**Compliance Status.** Of the 66 DHHS tanks, regulatory inspections have identified issues of non-compliance in 4 cases. Of these 4, two have already been corrected and the remaining two are currently in the corrective action process. Tables 6a &b provide specific data on these non-compliant tanks. Of the remaining tanks, 18 have been inspected by a regulator and determined to be in compliance, 2 have been inspected and are awaiting results from the regulator, and 42 have never undergone a regulatory inspection. Tables 7a, b, & c provide specific information on these tanks.

**Training.** To date, DHHS has provided operator training for 22 of its 66 tanks. As EPA and the States develop specific training requirements in accordance with the Underground Storage Tank Act of 2005, DHHS will begin to integrate such training into all of its UST programs.
