

The DERA program places a priority on projects that are located in areas that have the highest emissions from diesel engines. The term “project location,” as used in the Projects to Improve Air Quality at Ports - 2013 DERA Funding Opportunity, refers to the primary area where the affected vehicles/engines operate, or the primary area where the emissions benefits of the project will be realized. Please note that applicants may apply for projects that are not located in priority areas.

These counties and areas were selected as priority areas for the DERA program based on data from a number of sources. The sources include counties and areas:

Designated as PM_{2.5} or 8-Hr Ozone Nonattainment Areas or 8-Hr Ozone Maintenance Areas. Data is sourced from EPA’s Green Book of Nonattainment Areas for Criteria Pollutants.
