



How Do I Retrieve My Quality Assurance Feedback?

Introduction

Each time you submit an EIS CERS XML file to the Emissions Inventory System through the CDX Node, whether it is to the QA or Production environments, you will receive feedback. The purpose of this section of the EIS Users Manual is to provide instructions on how to locate on the EIS Gateway and download your quality assurance feedback.

Step 1:

From within the EIS Gateway, you will see on the left side of the page a heading entitled “Account Data.” Under this heading, select the option “My Agency.”

Step 3:

The Submission History window will appear containing a table of all the submissions made for your agency. The table contains:

- The CDX tracking number
- Status of the submission
- The name of the person who submitted the file
- The category of data in the file
- The type of submission, either QA or Production
- When the file was submitted
- A link to download the report

Each column within the table can be sorted by clicking on the column header. At the bottom of the page is a link to download the table in CSV format.
