U.S. EPA Urban Waters Small Grants

The U.S. EPA expects to award up to \$1.6 million in funding for projects taking place in 18 Eligible Geographic Areas that protect and restore urban waters by improving water quality through activities that also support community revitalization and other local priorities. Small grant awards under this competition will range in the amount of approximately \$40,000 to \$60,000 in federal funding. The funding is part of EPA's Urban Waters program, and is one element of support EPA is providing to the goals of the multiagency Urban Waters Federal Partnership.

The Foundation's Every Day Capacity Building Grants, sponsored by Toyota, offer support to nonprofit organizations, such as "Friends Groups," whose missions are focused on the improvement and responsible use of public land sites throughout the nation. In the upcoming funding round, twenty-five grants of up to \$5,000 will be provided to increase organizational effectiveness so that grantees can better serve public lands.

Wilderness Inquiry Visits Michigan City

On September 23rd through 28th, Michigan City youth and families were able to experience an unforgettable paddling adventure at the Trail Creek Voyageur Canoe Days event. The 24

foot long Voyageur canoes, from the Wilderness Inquiry Canoemobile, served over 600 school children during the week with a public paddle offered on Saturday. The paddle took place on Trail Creek; additional educational activities were held at the Michigan City Port Authority. This effort, spearheaded by multiple organizations involved with the Urban Waters Federal Partnership and the Trail Creek Watershed Steering Committee, leveraged funding from the Michigan City Community Enrichment Corporation and a U.S. EPA Clean Water Act 319(h) grant (awarded by the Indiana Department of Environmental Management).
