- 2. Promote clean urban waters that are safe for recreation, drinking water and aquatic life.
- 3. Through education, help people understand where their water comes from and where it goes and their role in protecting it.
- 4. Protect source water and help to ensure a reliable water supply and maintain the health of our forested source water areas.
- 5. Work to restore and revitalize the river environment.
- 6. Look at this as a collective urban ecosystem. Interconnected network of waterways and trails. (America's Great Outdoors (AGO) Landscape).
- 7. Green Jobs adults and youth.
- 8. Sustainable environmental agreements and business processes. Put it on paper.
- 9. Give a voice to under-represented populations.
- 10. Through education, help people understand the value of the river in our lives and the role that it serves.

(John Novick, City of Denver) City wide master plan – ID sites in area Would like to use as a model for interagency cooperation .

(Gordon. City of Denver) Need to restructure the river through Denver.

Need to purchase/remove/roads/banks.

Need \$ to do so. Will put resources toward the 5 city projects and look for partners. Look for more projects to restore the banks.

(Dave, Denver Greenway) Look to take advantage of economic development

Have developers incorporate water/river into their plans and open to public

Trashcan campaign....public led.

Need to build on public/private partnerships

Have community input....Make sure EJ communities have a voice

Sun valley ex.

Make river accessible – 5 areas identified are mostly industrial.

Earth Force can help bridge the gap between community and project. Youth led. Build into the model the idea of safety.

Still a concern to invite people to the river when there are areas that are still unsafe...mixed message since don't want people in these areas.

Denver – 5 projects How to involve the parties? Not only about bringing money to the table Still need the expertise Wetland development etc.
