List of Areas of Poor Air Quality

The DERA program places a priority on projects that are located in areas that have the highest emissions from diesel engines. The term “project location,” as used in the 2014 DERA Ports RFP, refers to the primary area where the affected vehicles/engines operate, or the primary area where the emissions benefits of the project will be realized. Please note, only applications for projects that take place in areas of poor air quality, listed below, will be considered for funding under the 2014 DERA Ports RFP.

These counties and areas have been identified as areas of poor air quality because they are:

Designated as Particulate Matter (PM) 2.5 or 8-Hr Ozone Nonattainment Areas or 8-Hr Maintenance Areas.
