Letter of Complaint to you

I was browsing the Internet, trying to bring awareness to a problem that I have been having, something that I go through is how I am able to even write what I now know. You see; I am physically disabled and have been this way for twelve years or more, and I got this way, physically disabled from what supposedly was to have been medical malpractice, but I have found out differently over the years.

I would like for you to be aware, that I am know that I am a regular common citizen of the United States of America, who has not been all that fortunate, but have been blessed with life itself. So when someone like myself is brought to realize something that deeply affects me and all who are of me, meaning my family, friends and neighbors, I felt that immediately something should be done, but what I found out is that there are ways that people can kill a person or like me, make them disabled and leaves no trace of any wrong doing, what so ever, and even more the people who are doing this have been getting away with it for a very long time.

I cannot tell you how shocked I was to find out that people are using Radiation, in our streets as a weapon and can control that Radiation, to expose a person long enough just to get that person sick and disabled or if they wanted too, as they have already, kill that person.

I am writing to you because I have already lost several members of my family and friends this way and have even noticed the biological changes that come from the exposure to Radiation, but this Radiation is also in use with what I believe to be Jet Fuel and other chemicals, making it a suspension of some kind.

And before you ask who this all is, who is doing this, it is something that I as well have been trying to find out, so I am admitting to you, that I am making this letter of complaint out to you, without any evidence, except for what I know to be true and have also found a way to prove what I am claiming, as I have made countless letters, forms and other means of standard ways of complaints that should have gotten the people caught, but in an indirect way that can expose certain realities that are very hard to prove exist and are responsible for a persons death or the death of many.

Some of my complaints can be found at the Department of Health: Commissioners office and the City, States office of the Attorney General, as I have made letters of complaints, that are of Allegations, to these offices and many more about what the lack of being able to prove these ways of taking or debilitating someone's life, how in our Environment, Racism has formed and let the people who are involved in this and involved in Electronic Surveillance and what ever else, they have gotten away with. As there are in particular a large group who follows me around, since my childhood, but I just found out after I was made physically disabled. I have never participated in any kind of Electronic Surveillance, as the way this in particular kind is done through a person head, some real crazy stuff.

This I have to fight against and at the very same time I can't see it or do I know how to find it, so I am made to look crazy and have been done this way by my country, as I have lived in the states of New York,

Mississippi, but I have moved here to North Carolina in December of 1997, and have been followed to all these states.

So as you can read in this letter to you the Environmental Protection Agency: office of Civil Rights, that there are chemicals involved and the negative uses of our Air, and being that I have been told by anyone that they were interested in my crusade against this, if I were you I would beware of anyone coming in reference of this seeming to come as bearing gifts, as this letter and many more to you I may not get an answer to, as I have written to you before about this and have gotten nothing. I always ask you whomever I fax, to not fax me back, because I have gotten faxes that denied me assistance for the help I requested and had to pay the faxing service I use the cost, so please do not fax me back. I have spend what I feel to be necessary for you to know of my plight for your help.

I first started writing about this to my government, in particular the Department of Justice: offices of Civil Rights; Coordination and Review Section, NYA, Fax: (202) 307-0595 and the Appellate Section, PHB, Fax: (202) 514-8490 and the Disability Rights Section, NYA, Fax: (202) 307-1198, I have put these offices fax numbers here, because these are the actual numbers I have used. I use to mail my letters to them, but I started noticing that my mail was not reaching them and the matters are of great importance to me and I really wanted someone to know that I was going to need help with bring to court what could also be considered as, bringing the awareness of the world's public our vulnerabilities have always been known to those who do not have our best in mind for people like you and me. But instead I have not gotten any help from them and what mail I have gotten from them seems very much to be fraud. And even more I feel that someone has been making my letters of complaint disappear as they come right out the fax machine, I send to them at the Department of Justice.

This brings me to why I write to you today, because of what I believe to be Environmental Racism, as first I am discriminated against, by those of my own skin color and others of my community, because pressures of their sinfulness and what they must have done that could have them end up in jail, could be exposed and they have to keep me from bringing them to a court of law and so the complaints I make against them are, to me discriminated against and this is especially my concerns towards my mail, as I can not get my mail when it comes to me communicating with who I write too. My states postal inspections service seems to be a part of this, as I have made countless complaints to their office as well.

But these people who have done these crimes against me, can't be the very same one's who have the resources to get to the people I write to, so there is someone fully capable of exercising their power and I believe that it's either a person of Caucasian or Foreign decent. If I was given the opportunity to bring my complaints to a court of law with the help of my government behind me I could stop and expose something that has not only greatly damaged my life, but also the lives of many others, of all colors and origins all across this world.

I would greatly like for you to understand how if something within our Environment is not treated with the respect that all the other laws uphold, it can make life very difficult, especially if that aspect of the Environment, has things in it that are of our moods, how they swing and is a controlling stressor to the human body, in which I was able to find a Behavioral Stressor; of the Federal Aviation Administration: Human Factor research; study. This particular study is what I have found that comes very close to what I have been going through, as the chemical Jet Fuel, is a toxic substance and known among the people who suffer, as I do with Sarcoid. This is someone's cash cow and as you have read I have many reasons for getting this or these people in a court of law, so can you help me? Can you step in and direct the Department who may not understand, but may have realized that other violations and crimes were committed but that it goes up on a different level in our society, even International. I would also like to say to you and anyone else who may take interest that I did not ask for this, to be alone in fighting against something that our government has not agreed exist in our streets environment.

9/15/2005 12:39:47 PM, was maybe the last time I wrote you. I wrote to the FAA's office of Civil Rights, but nothing about the chemicals and the adaptation of their research study, and I have not heard from them, the same with the office of Civil Rights everywhere. No one has taken interest. Will you! I have still been asking Civil Rights of the Department of Justice for their help and have done so just recently. This letter has been written and signed by me:
