I Experienced An On The Job My Ankle Was Damaged By The Garbage Truck Driver Stopping The Truck and Moving Off Again Without Warning. In The Interim I Injured My Ankle. I Was Then Out Of Work Without Pay For 6 Weeks In October To November 2005. My Workman Compensation Was Denied By The Employer. I Was Given A Release By The Above Mentioned Doctor To Go Back To Work On Light Duty. My Former Employer City Of Stamford Refused To Allow Me Reasonable Accommodation Whereas "(Reassigning A Current Employee To A Vacant Position For Which The Individual Is qualified)." And Stated I Could Not Return To Work Until I Had A Hearing.

I Was Discriminated By Age When At A Hearing Held On October 27, 2005 William Price The Head Of The Foremen At The Sanitation Department At The City Of Stamford, Mr. William Price Stated I Was Too Old For The Job Because I Was Getting Hurt A Lot On The Job. Mr. William Price Inflammatory Statement Was Based On An Employment Decision On the Speculation That I May Cause Increased Workers' Compensation Costs In the Future.

I Was Discriminated Against By So Called Race After Filed Grievance Stating That The Supervisors And Or Foremen For Solid waste Department That Represent The City Of Stamford Allowed A Select Group Of Caucasian Males Weekly And Or Holiday Pay Overtime While Ignoring The Majority Of Workers Of Color And Women (There Is Currently A Long Standing Unresolved Grievance The Current Union Has Against The Employer City Of Stamford On Behalf Of The Union Member Dealing Specifically With Lack Of Overtime Being Distributed Equally).

I Was Discrimated Again By So Called Race As The Grievances Filed Will Prove That A Co-worker Was Allowed To Leave Work Every Pay Day Friday For Nine Months In 2005 To Meet His "Dealer." I Left Work One Hour Early (After A Completed Route)

Because Of Reported Complaints Of Gushing Defecation And Was Suspended For Three Days Without Pay.
