## **Office of Economic Resilience 101**

- Created (as OSHC) in 2010 as part of Obama Administration's Partnership for Sustainable Communities
- Aligning federal investments in housing, transportation, infrastructure and the environment by leveraging private, philanthropic and local government funds and catalyzing hubs of opportunity across the country
- Sustainable Community Initiative Helping 143 rural, suburban, and urban communities link jobs with transportation and housing, foster long-term economic growth, and protect America's environment through Regional Planning and Community Challenge grants. Touches 40% of the U.S. population.
- Sustainable Housing Initiative Coordinates across Agency to meet HUD's energy and green building goals and Climate Action Plan responsibilities.
- **Resilience (economic/climate)** Increased office focus

## HOW We Work

### **Regional Planning Grant Program**

- \$170 million in FY2010 and 2011
- Multi-jurisdictional, regional entity, and non-profit partnerships to develop a Regional Plan for Sustainable Development
- Plans will integrate housing, land use, economic and workforce development, transportation, and infrastructure investments to address:
  - (1) economic competitiveness and revitalization;
  - (2) social equity, inclusion, and access to opportunity;
  - (3) energy use and climate change; and
  - (4) public health and environmental impact.





## HOW We Work

### Community Challenge Grant Program

• \$70 million in FY2010 and 2011

- Fosters reform and reduces barriers to achieving affordable, economically vital, and sustainable communities.
- Funded activities include amending or replacing local master plans, neighborhood plans, corridor plans, zoning codes, and building codes
- Promote mixed-use development, affordable housing, the reuse of older buildings and structures for new purposes, and similar activities with the goal of promoting sustainability at the local or neighborhood level.

FY2010 Grantee Spotlight: \$500,000 HUD Community Challenge/DOT TIGER II Grant

### The Bridge Boulevard Corridor Redevelopment Plan, Bernalillo Co., NM

Project Summary: Redevelopment plan to create a mixed-use, pedestrian and transit friendly corridor on busy river crossing to attract new businesses and affordable housing while honoring the region's unique history and character.

- County projects it will attract nearly 100 new businesses and 700 new jobs
- Main Street Designation
- Urban Waters Designation (Middle Rio Grande)



### Drawing Lessons-

### **Community Involvement: a Significant Element**

- New tools: scenario planning, open source, new media, surveys, etc
- New voices: business, builders, lowincome, minority, youth
- Capacity building resources targeted to improve, expand reach and impact

Housing:

•Replace distressed public and assisted housing with high-quality mixed-income housing that is well-managed and responsive to the needs of the surrounding neighborhood;

People:

•Improve educational outcomes and intergenerational mobility for youth with services and supports delivered directly to youth and their families; and

Neighborhood:

•Create the conditions necessary for public and private reinvestment in distressed neighborhoods to offer the kinds of amenities and assets, including safety, good schools, and commercial activity, that are important to families' choices about their community.

### CDBG – Block Grants

- Beginning in 1974, the CDBG program is one of the longest continuously run programs at HUD. The CDBG program provides annual grants on a formula basis to 1209 general units of local government and States.
