- 3. **Drew Kodjak is now co-chair of the Air Toxics Workgroup**. As a result of some organizational changes in the Office of Transportation and Air Quality, Drew Kodjak has succeeded Jean-Marie Revelt as co-chair of this workgroup. Jason Grumet of NESCAUM remains as the other co-chair. Drew is located at EPA's National Vehicle and Fuel Emissions Laboratory, 2000 Traverwood Drive, Ann Arbor MI 48105. The workgroup met by conference call on August 15 and plans to meet face-to-face in Ann Arbor on Tuesday, October 10, a day before the MSTRS meeting which is scheduled for October 11 at the DaimlerChrysler Technical Center in Auburn Hills (a northern suburb of Detroit).
- 4. **Mike Kulakowski and Bob King are leaving the subcommittee**. Mike (Equiva) has a new job and Bob (Sun) has retired. Both could always be counted on to provide us with unique and valuable inputs from the perspective of the fuels industry. Selection of replacements will probably wait until after our parent committee is rechartered in November but representatives of the fuels sector are encouraged to attend the October meeting to see if they may be able to learn and provide valuable input.
- 5. International Emission Inventory Conference: Call for Papers. "One Atmosphere, One Inventory, Many Challenges" will be held April 30 May 3, 2001, at the Adams Mark Hotel in downtown Denver, Colorado. This is the tenth annual symposium on emission inventories and is sponsored by the U.S. Environmental Protection Agency, Office of Air Quality Planning and Standards, Emission Factor and Inventory Group, with the assistance of the Western Regional Air Partnership and the Colorado Division of Air Pollution Control.

The technical program committee is interested in papers that describe new developments in methodologies for characterizing and inventorying air pollutant emissions, especially in emerging programs such as air toxics, regional haze, and fine particulate matter. Also of interest are papers related to continuing developments in the ozone program. This conference will provide a useful
