



What is the Commuter Choice Leadership Initiative:







- A new voluntary businessgovernment partnership
- Modeled after Energy Star
- Cited in National Energy Plan
- Full program began June 2001
- National Standard of Excellence
- Builds on tax changes for commuter benefits
- Partnering with U.S. DOT
- A practical solution to traffic congestion, air pollution, worker productivity, & energy security

Why a Commuter Choice Leadership Initiative: Rapidly increasing traffic is ...



Problem for U.S. energy security

- 7B gallons of wasted fuel/year & increasing Problem for U.S. business & workers
- Causing delay of 36 hours/year/person
- up from 11 in 1982
- "Rush hour" now lasts 6 or 7 hours/day
- \$80B per year in lost productivity & fuel
- 4.5B hours of delay per year


Problem for the U.S. environment

- Miles traveled up 75% from 1980 to 1999
- 80% were "drive alone" trips
- Light duty vehicles cause 20% of CO2

What is the Commuter Choice Initiative: Employer responsibilities







- Appoint coordinator &
- Centralize information
- Inform employees of benefits
- Offer 1 primary benefit from list:
 - \$32.50 per month per employee in transit or vanpool pass
 - \$32.50 per month per employee in parking cashout
 - > 6% of workforce telecommuting
- Offer 3 secondary benefits from menu
 - Preferred carpool parking
 - Locker room or showers
 - > 20+ other options
- "Guaranteed ride home"
- 14% minimum participation rate
- Report progress




