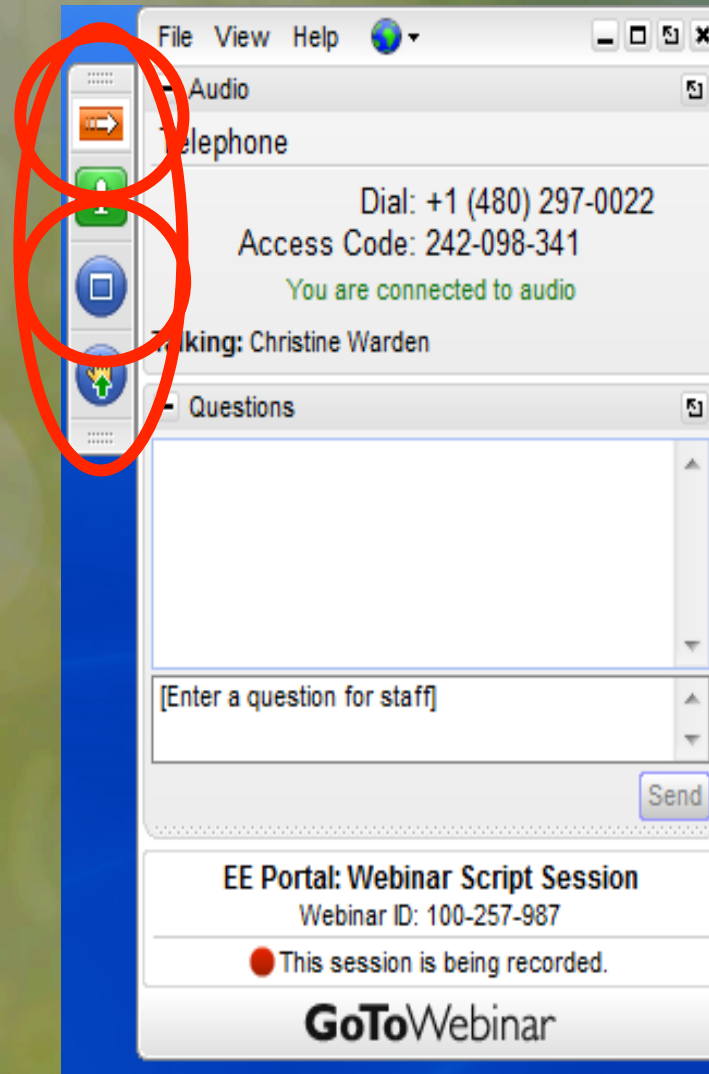

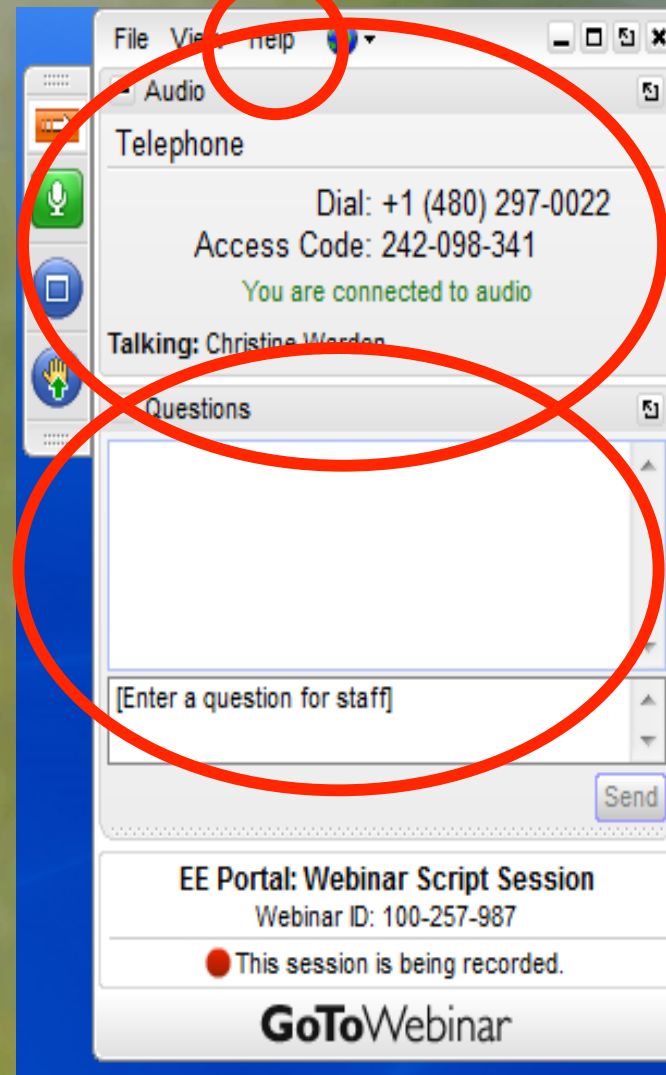

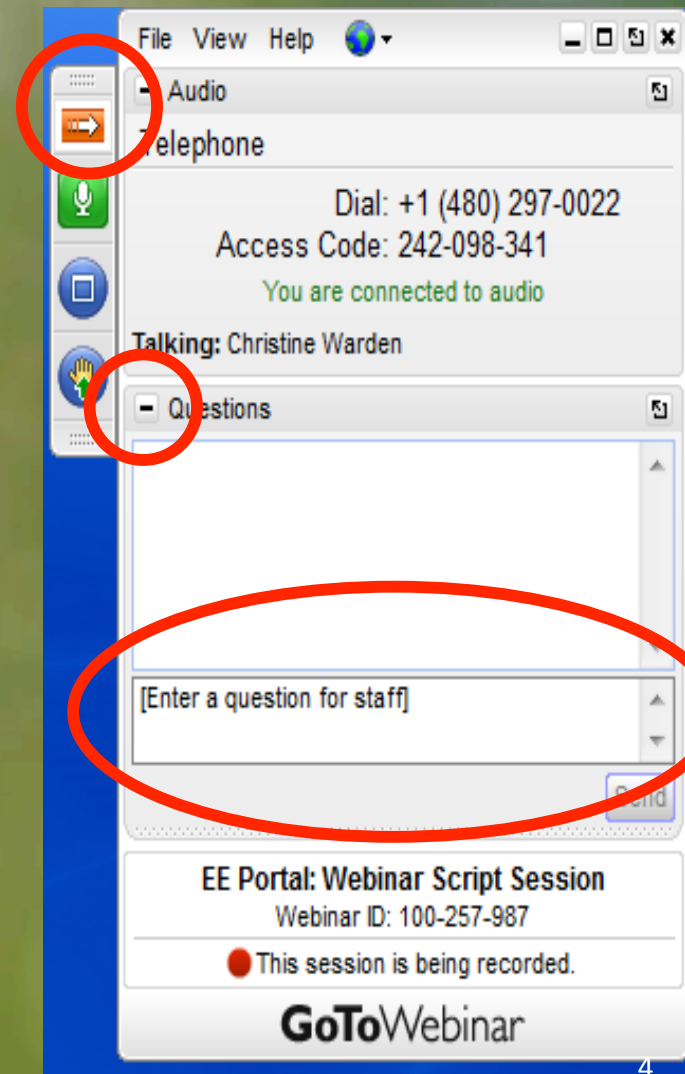

Vision

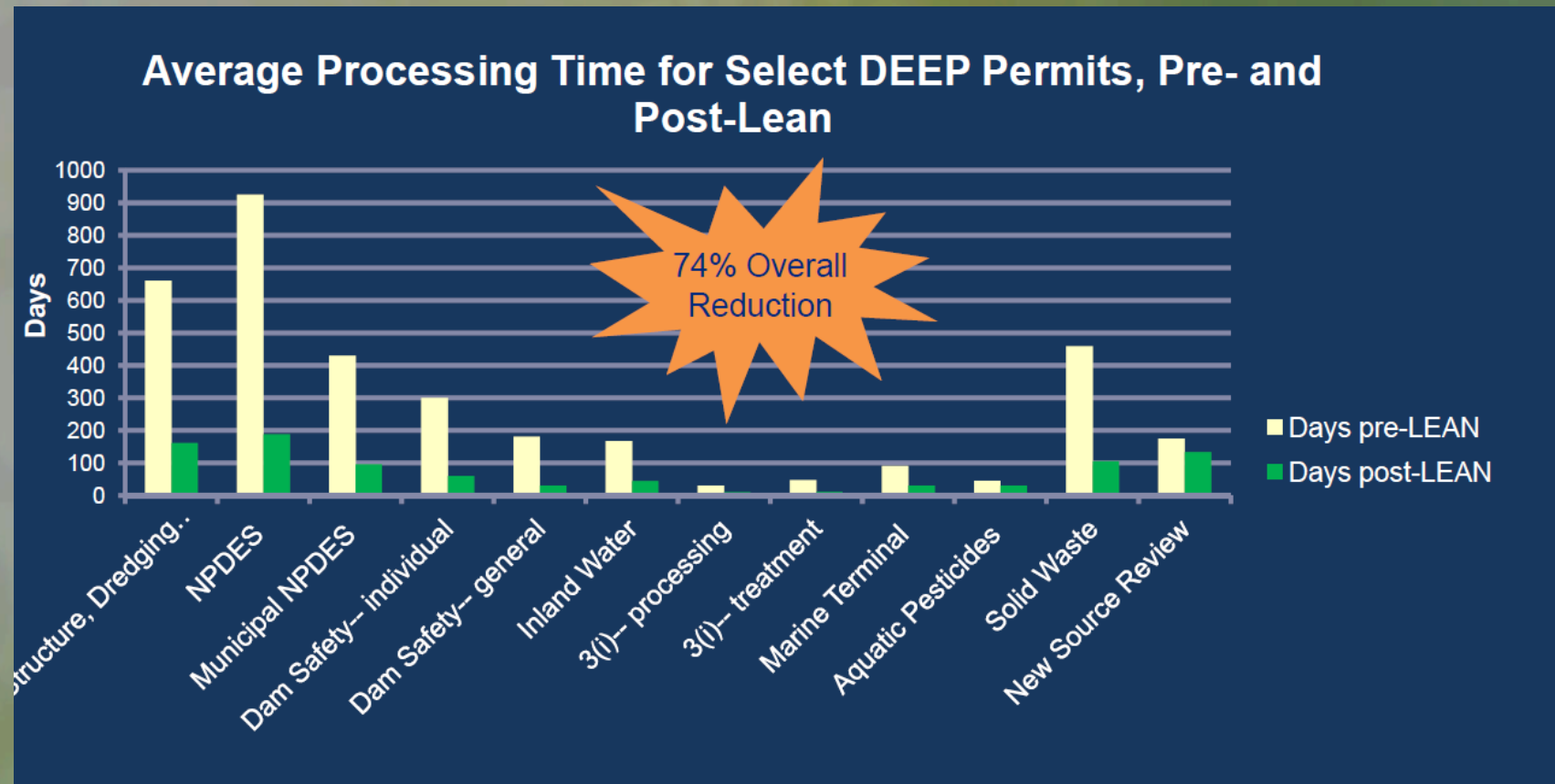
A modern, well-integrated, national enterprise of environmental protection jointly governed by states, tribes and EPA.

Protecting the environment through modern business processes, technology, and partnerships.

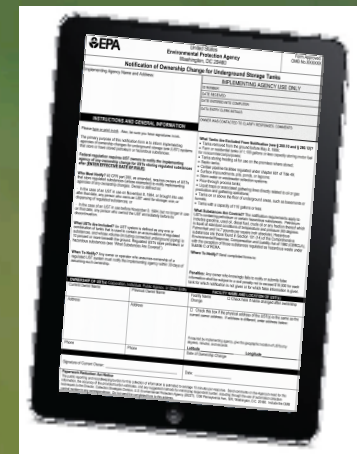
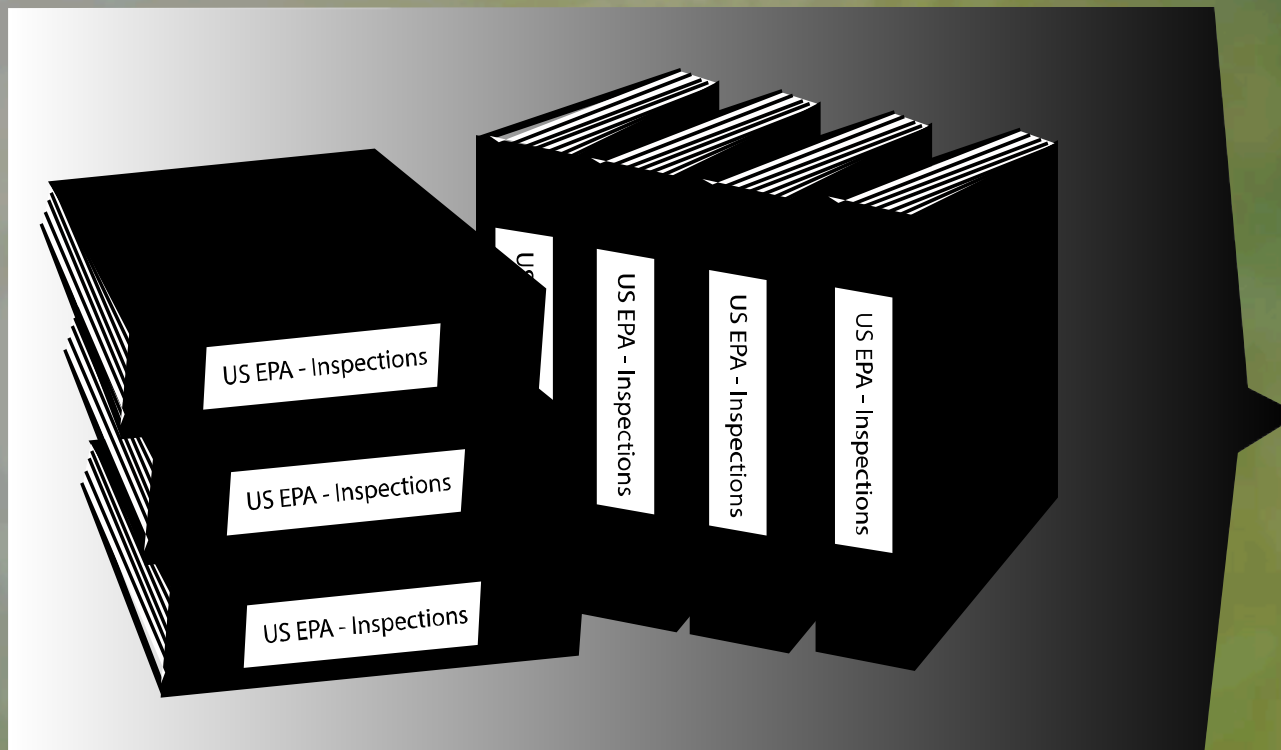



E-Enterprise Portal Overview

The Portal Concept

- Enhanced user service is a goal of E-Enterprise and the portal concept is central to that vision.
- It has the potential to provide a consolidated entry point for business and citizens to:
 - Efficiently locate,
 - Obtain access to, and
 - Interact with relevant EPA, state and tribal environmental programs and web resources

Why Do We Need the Portal?

- Environmental programs have been developed over time under statutes that have used different approaches and funding mechanisms to address varied environmental problems.
- There have been dramatic improvements in environmental protection and systems that support them but challenges remain.
- Stakeholder communities expect programs to be modern, efficient, and provide better service.

How Could Regulated Entities Benefit from the Portal?

Potential benefits of the portal may include:

1. Eliminating redundancies by only having to enter your information once.
2. Identifying errors and omissions quickly.
3. Ability to track the status of your transactions.
4. Clarifying reporting requirements.
5. Enhancing compliance assistance.

How Could Co-Regulators Benefit from the Portal?

Potential uses for co-regulators with the portal include:

1. Easier access to comprehensive data to inform decision-making.
2. Improved data quality through electronic reporting and the use of shared services.
3. Shared infrastructure: build once; use many.

How Could the Public Benefit from the Portal?

Potentially easier access to customized information such as:

1. Localized data – ambient environmental conditions in your area, new or modified permit information, and local educational and volunteer opportunities.
2. Customized notifications and alerts of new research results, new or revised regulations, program information, and details on specific environmental issues.
3. Ability to drill through a summary analysis to access the underlying data and metadata.

Portal Timeline

EPA is in the process of scoping the portal.

- Implementation will be incremental.
- First phase will be foundational.
- Comprehensive scoping phase mandated by statutes and regulations.
- It is our intent to have some capabilities this Fall.


