Subject: U.S. EPA Assessment of Walter Coke Voluntary Investigation and Cleanup Report for Hudson School – dated June 17, 2011


Dear Dr. Witherspoon:

The U. S. Environmental Protection Agency's Resource Conservation and Recovery Act (RCRA) Division has completed its review of the Voluntary Investigation and Cleanup Report for the Hudson School, dated June 17, 2011 (Report), submitted by Walter Coke, Inc. The Report included details of the soil investigation activities at the Hudson School which took place during July 13-28, 2009, and later, from August 31 to September 1, 2010, after construction of the new Hudson K-8 School was completed. School soil remediation work described in the Report was completed by Walter Coke on June 8, 2011.

The soil remediation consisted of removing 52,000 cubic feet of soil to a depth of 2 feet and replacing it with clean backfill. EPA observed some of the soil remediation. After careful review of the Report, the EPA's RCRA Division has concluded that based on Walter Coke's analytical data, the soils at the school do not exceed a human health risk level of 1 in 10,000 increased cancer risk for Benzo(a)pyrene toxicity equivalents or a hazard index of 1 for arsenic.
