## **Draft Team 2 Work Plan Outline**

#### **Audiences**

- Team 1
- SIP planners in nonattainment areas
- Air Quality Management Agencies
- EPA and the CAAAC
- NRC.

### **Process/Tasks**

1. On parallel tracks, (a) identify specific needs/problems/categories of issues for which the team should develop tools and/or strategies, and (b) brainstorm specific tools and strategies that may be available to address one or more needs/problems/issues.

The scope of this task should include:

- Short term needs and tools targeted toward current SIP planning efforts to address nonattainment;
- Long term needs and tools targeted toward Team 1's design of a new AQM planning process;
- Links back to one or more of the 15 components identified at the Ann Arbor meeting, especially the 6 high priority components
- Needs and tools that can be done within current authority and those that require new/revised authority

In this task it is important to keep in mind:

- Phase 1 short term measures that are currently under development should not be repeated in this task;
- Different sectors may require different tools
- Some tools/strategies may require more/different resources than those present on the Team will EPA provide those resources?

Examples of possible needs/problems/categories of issues include:

- Addressing airport emissions
- Addressing VMT growth
- Addressing emissions from consumer products
- Land use, transportation and air quality planning
- How to apportion credit for reductions achieved by diesels that move across country
- How to give US automakers credit for ghg reductions
- What problems do cap and trade programs fail to solve (what has and has not worked)?

Examples of possible tools and/or strategies include:

• Information sharing system for states/locals to use to find new/innovative strategies that have been implemented in other states/jurisdictions

- Revenue stream that small businesses can use to help them implement strategies
- **2.** Perform a cross-check of needs/problems/issues versus tools and/or strategies to fill any gaps in this part of the process.
- **3.** Identify attributes and/or criteria that the team needs to research and examine for each of the tools and strategies under consideration.

Examples of possible attributes include:

- Type and amount of environmental benefits
- Applicable jurisdictions
- Accountability
- Replicability
- What collaboration is required
- How the tool/strategy affects quality of life
- Tool/strategy's impact on energy efficiency/greenhouse gases
- **4.** Identify barriers/issues that have to be addressed in order to be able to develop/implement each tool/strategy
- **5.** Create user-friendly formats/structures for capturing, examining and reporting the information gathered and developed for the project
- **6.** Draft outlines/issue papers on each tool/strategy summarizing the information developed
- **7.** Evaluate each tool/strategy against the attributes and criteria which ones best address the needs/problems/issues identified.
- **8.** Determine tools/strategies that team will put forward as recommendations. Determine how to deal with any tools/strategies that will not be included as a recommendation.
- 9. Update outlines/issue papers determine format of final product/deliverable
- **10.** Draft final product/deliverable and circulate for comment.
- 11. Complete final product and submit to EPA and CAAAC
