1) List the current beneficial use impairments in your RAP and summarize the activities underway and planned to restore each beneficial use and make progress towards AOC delisting. (This is a big picture or 10,000 ft view of the major actions needed to delist the AOC)

The following Management Actions have been identified and need to be completed in order to satisfy delisting targets for removing the Impaired BUIs for the Buffalo River AOC.

- Completion of the Phase II Great Lakes Legacy Act Sediment Remediation (this assumes Phase I Enhanced Navigational Dredging is completed satisfactorily),
 Status as of September 2014 This project began in late 2013 and has
 - Status as of September 2014 This project began in late 2013 and has removed approximately 350,000 cubic yards of contaminated sediment from the River. It is anticipated that the dredging and capping process will be completed in October 2014.
- 2. Restoration of five aquatic habitat restoration sites included as part of the Buffalo River Great Lakes Legacy Act Sediment Remediation project,
 - Status as of September 2014 the placement of fill material and installation of rock vanes began this month. The installation of planting material and SAV and EV is anticipated to occur in June 2015.
- 3. Conduct Great Lakes Legacy Act Sediment Remediation project 2 and 5 year performance monitoring (includes residual monitoring of sediment quality and aquatic habitat restoration)
- 4. Complete implementation of RiverBend Habitat Restoration Phase I and Phase II, and
 - Status as of September 2014 Phase I restoration work has been completed; Phase II restoration will commence in the spring of 2015.
- 5. Design and implementation of a set of 13 priority aquatic/upland habitat connectivity projects identified in the Buffalo River Habitat Restoration Action Plan.
 - Status as of September 2014 please see following chart.

In June 2014, the "Buffalo River Area of Concern: A Monitoring Plan for the Delisting of "Impaired" Beneficial Use Impairments" was finalized. The development of this plan began with the formation of two "Sub Groups" comprised of people with expertise or significant interest in either Habitat or Water Quality issues. It was determined early on in the process that the Delisting Criteria for all of the BUIs needed to be updated to reflect current data and to assure that the goals were reasonable and obtainable. The Monitoring Plan is intended to supplement the updated BUI chart by outlining the sampling efforts needed to redesignate the Buffalo River AOC, post Management Actions. Anticipated sampling needs include (but not limited to):

- Post-Dredging monitoring 2yr & 5yr
- Completion of NYSDEC's 3-yr phenol study
- Wildlife Survey
- Completion of USGS tree swallow survey
- Completion of NYSDEC's mink survey

3) Based on your current progress and planned activities, what is your best estimate of the year when your RAC would be ready to proceed with a final Stage 3 Area of Recovery designation or AOC delisting document?

We believe that the Buffalo River RAC would be ready to proceed with an "Area in Recovery" designation in 2016. Once post dredging and post-habitat restoration monitoring is commenced, complete, and the data supported, barring any further funding delays, we believe that the Buffalo River RAC would be ready to proceed towards a final Stage 3 Delisting document in 2018-19.

4) When does your current RAP capacity grant funding run out? What will be your future RAP capacity needs by year with estimated dollar amount to accomplish BUI removal and AOC delisting targets described in questions 2 and 3 above?

A detailed analysis to determine funding needs has not been performed and estimating the cost for RAP capacity funding is made difficult by the varying (and often unknown) project tasks. That being said, it is anticipated that personnel costs associated with RAP coordination and project oversight will range from \$150,000-200,000 per year until the Buffalo River has been delisted or designated as an Area in Recovery.

Buffalo Niagara Riverkeeper will receive funding of \$103,000 per year for Buffalo River RAP Coordination through the end of 2016 as part of an EPA grant obtained by Erie County. The gap in funding will impact the ability to complete tasks listed in the grant agreement – particularly the development of a delisting document for BUI #11 (Aesthetics).

- 5) What barriers (policy, funding, technical, other?) are RAP Coordinators encountering to tracking BUI activities and progress towards removal?
