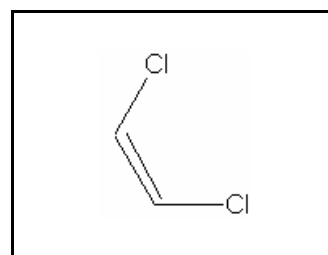




TIER II ACUTE AND CHRONIC AQUATIC LIFE VALUES

CIS-1,2-DICHLOROETHYLENE

CAS RN: 156-59-2
Water Solubility: 0.08 g/100 mL

Standard

The procedures described in the Tier II methodology indicate that, except possibly where a locally important species is very sensitive, aquatic organisms should not be affected unacceptably if the four (4) day average concentration of *cis*-1,2-dichloroethene does not exceed 620 $\mu\text{g/L}$ more than once every three (3) years on the average and if the one (1) hour average concentration does not exceed 5,500 $\mu\text{g/L}$ more than once every three (3) years on the average.

Calculations

Acute Aquatic Life:

$$\text{SAV} = \text{lowest GMAV/SAF}$$

$$\begin{aligned}\text{Lowest GMAV} &= 144,000 \mu\text{g/L} \\ \text{SAF} &= 13.0\end{aligned}$$

$$\text{SAV} = 144,000/13.0 = 11,077 \mu\text{g/L}$$

$$\text{SMC} = \text{SAV}/2 = 11,077/2 = 5,500 \mu\text{g/L}$$

Chronic Aquatic Life:

$$SCV = SAV/SACR$$

$$SACR = 18$$

$$SCV = 11,077/18.0 = 620 \mu\text{g/L}$$
