Please comply with with Section 106 of the National Historic Preservation Act in relationship to consultation with federally recognized Tribes opposed to Cape Wind.



The National Historic Preservation Act established the ACHP. ACHP is the only entity with the legal responsibility to encourage federal agencies to factor historic preservation into federal project requirements.

The ACHP recommended that Secretary Salazar deny Cape Wind, and the Secretary ignored the ACHP and approved Cape Wind.
