PMN Security

- Browser-based application
- Submission of PMN Data facilitated via EPA's Central Data Exchange (CDX)
 - Enables companies to electronically submit data
 - Provides secure exchange of confidential business information (CBI) data
 - Improves security using digital encryption
 - All data is encrypted in transit to Federal Standards
 - Sensitive data is encrypted at rest to Federal Standards
 - All sensitive data remains encrypted at rest until it is behind at least 2-3 Firewalls.



Overview of ePMN Role Changes

- Old eTSCA CDX Registration Roles
 - Authorized Official (AO)
 - Support Registrant (SR)
- New CDX Registration Roles (CSPP workflow)
 - Primary Authorized Official (Primary AO)
 - Primary Support
 - Secondary Authorized Official (Secondary AO)
 - Secondary Support



- What do we mean by "Primary"
 - Primary is a term associated with Main Submitters
 - Primary Submitters create/edit/submit the following Section 5 forms:
 - PMN, Biotech, Support Document **(correspondences, test data, amendments),
 Notice of Commencement (NOC)
- What do we mean by "Secondary"
 - Secondary is a term associated with Joint or Letter of Support Submitters
 - Secondary Submitters create/edit/submit the following Section 5 forms:
 - Joint PMN, Joint Biotech, Letter of Support**



^{**}Documents which can be submitted by non-US persons

- Who can be an AO?
 - Any member of the submitting company
 - Other persons such as agents/consultants with a business arrangement with the submitting company
- ESA agreement statement current language:
 - (13) Certify I have the authority to enter into this Agreement on behalf of the Organization identified above, and I am a signatory authorized to represent that Organization, and I am able to sign and submit reports and other information on behalf of that Organization in the capacity required by statue and/or regulation.



- What can AO do?
 - Without passphrase
 - Create any document (all AOs)
 - View a list of documents in the forms table created under that company name (all AOs)
 - In addition, with passphrase
 - Edit, delete, unlock to amend, and download Copy of Record submissions (all AOs)
 - Submit amendments and Support Documents (all AOs)
 - Certifying AOs submit the original Section 5 Notices (PMN, NOC, Biotech)



- Who can be an Support person?
 - Any person CDX registered under an approved AO
- What can the Support person do?
 - The Support person can edit the document to which he/she has been assigned by the AO and has been given the passphrase by the AO



List of submissions are viewed in a table based on the CDX registered company name of the document creator.

- How to limit exposure to documents in the forms screen
 - Register with a unique company name (e.g., Newchems polymers division; Newchems specialty chemicals)
- How to limit access to documents
 - Limit open/unlock/download access by securing a passphrase and only share it with those who need access

Key Enhancements

Multi-session Web Forms

 Forms can be completed in more than one session and be easily accessible via multiple computers/users

File Integrity

Eliminates local file store, which was the main cause of file corruption

Firewall Conflicts

 Browser-based form bypasses most firewall issues encountered by the thick client

XML Upload Capability

 Direct data transfers via XML Upload for companies with their own data collection systems



Key Enhancements – Continued

Substance Registration Services Integration

 Integrated validation of chemicals utilizing integration with EPA Substance Registry Services

In-Form Amendments

- No longer a separate amendment process for new submissions
- Amendments can be completed by unlocking and submitting the new form.

Copy of Record (CoR)

 Application integration with CDX allows users to know when EPA received the submission. If the CoR icon appears, EPA has received the file

Joint Submission Enhancement

 Joint submissions can be completed separately and independently using designated roles







Chemical Information Submission System



Section 5 of TSCA, EPA's New Chemicals Programs, helps manage the potential risk to human health and the environment from chemicals new to the marketplace. Anyone who plans to manufacture or import a new chemical substance for a non-exempt commercial purpose is required by section 5 of TSCA to provide EPA with notice before initiating the activity. This premanufacture notice, or PMN, must be submitted at least 90 days prior to the manufacture or import of the chemical. Additional form types are listed to support different circumstances a chemical may be manufactured or imported under. The manufacturing or importing company must also notify EPA within 30 days after the start of the first manufacture or import.

Please note: The public reporting and recordkeeping burden for this collection of information is estimated to average 93 hours per response for PMN, SNUN, LVE and LOREX applications (TMEA is estimated to average 88 hours per response), including time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. Send comments on the Agency's need for this information, the accuracy of the provided burden estimates, and any suggested methods for minimizing respondent burden, including through the use of automated collection techniques to the Director, Collection Strategies Division, U.S. Environmental Protection Agency (2822T), 1200 Pennsylvania Ave., NW, Washington, D.C. 20460. Include the OMB control number in any correspondence. Do not send the completed EPA Form 7710-25 to this address.

TSCA Section 5 Notices and Supports Reporting rule requires any person who manufactures (including imports), processes, or distributes in commerce a chemical substance or mixture and who obtains information which reasonably supports the conclusion that such substance or mixture presents a substantial risk of injury to health or the environment shall immediately inform EPA of such information unless such person has actual knowledge that the Administrator has been adequately informed of such information.

User Management

USER MANAGEMENT

The Authorized Official is responsible for restricting a Support's access to select forms by assigning or unassigning them to each form alias. The Support can access and edit only those forms for which the Authorized Official has granted access. Select the form to manage from the drop-down menu, and assign a Support to the form by highlighting the individual and clicking the **add** link. To unassign a Support, highlight the individual and click the **remove** link. To highlight and assign or unassign multiple Supports, hold down the **Ctrl** or **Shift** keys on the keyboard and click each Support before moving. You must click the **Save** button after each form alias assignment.
