On February 19, 2008, the Office of Inspector General (OIG) issued the report, "*Framework for Developing Tribal Capacity Needed in the Indian General Assistance Program.*" The report contained three recommendations related to the Indian General Assistance Program (GAP). The Agency agreed to take corrective actions to address all three recommendations.

We plan to follow-up on the 2008 report and the Agency's corrective actions. We plan to focus our review on EPA Regions 5, 6, 9, and 10 because they were part of the 2008 audit and are also the four regions with the largest number of tribes. The objectives of our follow-up audit are to:

- 1. Determine what corrective actions the Agency has implemented to address the findings from the prior audit report.
- 2. Determine if the corrective actions have been effective in addressing the findings from the previous report.

We will arrange a mutually agreeable time to discuss our objectives and planned work, ideally within the next 14 days. We will answer any questions you have about the review process, reporting procedures, methods used to gather and analyze data, and products you should expect. To expedite our review, we request that you provide us the information contained in the attachment to this memorandum by March 15, 2012.

## **OIG Document Request**

We located many documents online and excluded those from our request. If there is a version of any document, including drafts, that is more current than the document posted online please provide it.

- 1. EPA's definition of "Tribal Capacity."
- 2. Final version of the *Guidebook for Building Tribal Environmental Capacity (GAP Guidebook)*.
- 3. The updated GAP funding allocation methodology.
- 4. A list of EPA's GAP performance goals and performance metrics.
- 5. The names of the data system(s) EPA uses to capture and measure GAP program performance.
- 6. The amount of GAP funding provided to all Tribes during Fiscal Years 2009-2011.
- 7. The most recent annual report from the Administrator to Congress describing which Indian tribes or intertribal consortia have been granted approval by the Administrator pursuant to law to enforce certain environmental laws and the effectiveness of any such enforcement [note: this wording is from the Indian Environmental General Assistance Program Act of 1992].

  - Description of regional actions taken to address recommendations in OIG's 2008 audit report.
