4. Observations

The UNEP Guidelines from 2012 provide guidance for sustainable procurement by national governments, but could also be used for state and local government and potentially for other types of organizations. The steps follow similar guidance documents on SPP, with a greater emphasis placed on reviewing and meeting legal requirements, market analysis and prioritization in preparation phases, and on training in implementation phases. The guidelines and steps are intended to be flexible to accommodate different levels of maturity in SPP implementation; however it's likely to be of most use to those at an earlier stage. It is unknown as to the uptake of the Guidelines produced beyond those actively participating in related UNEP SPP programs and training sessions.
