EnergySolutions (Duratek) (Barnwell, SC)	After June 30, 2008, will accept waste only from Atlantic Compact states (South Carolina, Connecticut, and New Jersey)	http://www.energysolutions.com/ (801) 649-2000
US Ecology Washington (Richland, WA)	Accepts certain types of TENORM (although not hazardous or mixed) wastes from all states. Accepts licensed source material only from the states in the Northwest and Rocky Mountain Compacts (Washington, Oregon, Idaho, Montana, Wyoming, Utah, Nevada, Colorado, and New Mexico).	http://www.americanecology.com/richland.htm (509) 377-2411
EnergySolutions (Clive, UT)	Provides dedicated TENORM disposal and is the only LLRW landfill authorized to accept certain kinds of mixed waste. The facility will not accept some types of waste from Northwest or Rocky Mountain Compact states. Also accepts mixed waste (in excess of 100 cubic feet) for treatment and disposal.	http://www.energysolutions.com/ (801) 649-2000
Perma-Fix Environmental Services, Inc. (Gainesville, FL)	Licensed Treatment, Storage, and Disposal Facility (TSDF) for hazardous and mixed wastes, and can accept liquids, sludges, and solids.	http://www.perma-fix.com/ (800) 365-6066
East Tennessee Materials and Energy Corporation (M&EC)/(Perma-Fix) (Oak Ridge, TN)	A wholly owned subsidiary of Perma-Fix, located within the U.S. Department of Energy's complex near Oak Ridge. Permitted to store, treat, and dispose of liquid, sludge, and solid mixed waste.	http://www.perma-fix.com/mec/ (865) 574-0149
NSSI Sources and Services, Inc. (Houston, TX)	Accepts hazardous, mixed, and radioactive wastes for treatment, storage, and disposal and is also a permitted radioactive, mixed, and hazardous waste transporter. Accepts waste containing all radionuclides including special nuclear material. Waste is received and processed at its facility near Houston, TX, then shipped off-site for ultimate disposal.	http://www.nssihouston.com/ (713) 641-0391
