1	On-Going Assignment: Preparing draft report on oversight of EPA's Leaking Underground Storage Tank Program. Specifically, we seek to determine whether Agency oversight ensures that ARRA-funded LUST cleanups comply with applicable law, guidance, and regulation.
2	On-Going Assignment: Draft report in preparation on our assessment of the effectiveness of EPA's ARRA funding criteria in targeting job creation and retention and meeting infrastructure needs.
3	On-Going Assignment: Evaluation of EPA's Diesel Emission Reduction Act Grants Awarded Under the 2009 American Recovery and Reinvestment Act (ARRA). Have completed site visits to one State Grantee and one National Grantee. Our overall objective is to determine whether ARRA funds were effectively used on diesel reduction projects to obtain the intended diesel emission reductions. .The staff is currently developing a discussion draft report.
4	On-Going Assignment: Continued review of ARRA Brownfields grant guidance to determine if the guidance addresses or implements management controls or accountability measures for EPA oversight of All Appropriate Inquiry investigations funded by ARRA Brownfield grants. This work was initiated during an ongoing review of non-ARRA Brownfields grants.
