#### 50 Cities Initiative

On July 9<sup>th</sup>, at a press event in the Bosque at Central and Tingley, Albuquerque was named one of the first 24 locations in the Department of the Interior's "50 Cities" program. 50 Cities is part of the Interior Department's (DOI) broader Youth Initiative to engage the next generation of outdoor stewards and inspire millions of young adults to play, learn, serve and work in the great outdoors. The DOI is partnering with the National League of Cities, the national YMCA and its local affiliates, and American Express. Funding from American Express will create community coordinator positions in 50 US cities to increase awareness, support and participation in outdoor programs. These newly created positions are expected to engage thousands of volunteers in each city annually. American Forests - Three New Community ReLeaf Cities

Urban Waters locations are uniquely positioned for selection. As a new NGO partner of the Urban Waters Federal Partnership, American Forests – through the ReLeaf initiative – seeks to leverage the resources already invested in urban waters communities. Therefore, cities involved in the Urban Waters partnership will be given special consideration in the selection process. This program provides an average of \$100,000 in technical and financial resources to provide cities or metro areas with an assessment, survey, or site analysis to provide a scientific foundation, funds for tree canopy restoration, and outreach and policy support to help establish long-term improvement to the local tree canopy and its management. # USDA & Other Agencies – Local Foods, Local Places Technical Assistance

# **Deadline is September 15** (11:59 p.m. Eastern Time)

Supporting local food production can improve economic opportunities for local farmers and businesses, give residents better access to healthy fresh food, and spur revitalization of a main street, downtown, or neighborhood. Communities are invited to apply for technical assistance from the Local Foods, Local Places Program, which will provide direct technical support to selected communities. The assistance process features a community workshop that brings people together to develop shared goals and steps to achieve them. Representatives of communities anywhere in the United States are eligible to apply, especially communities that are economically challenged and in the early phases of their efforts to promote local foods and community revitalization. Special consideration will be given to communities in federally designated Promise Zones or USDA StrikeForce counties. #### NEA – Placemaking Grants

# Deadline is September 21

The National Endowment for the Arts (NEA) is accepting applications for the "Our Town" grant program, which supports creative, arts-centered placemaking projects. "Creative placemaking" is when artists, arts organizations, and community development practitioners deliberately integrate arts and culture into community revitalization work, such as land-use, transportation, economic development, education, housing, infrastructure, and public safety strategies. Our Town offers support for projects in two areas:

- Arts Engagement, Cultural Planning, and Design Projects represent the distinct character and quality of their communities and require a partnership between a nonprofit organization and a local government entity, with one of the partners being a cultural organization. Matching grants range from \$25,000 to \$200,000
- Projects that Build Knowledge About Creative Placemaking are available to arts and design service organizations, and industry or university organizations that provide technical assistance to those doing placebased work. Matching grants range from \$25,000 to \$100,000.

# USDA – Innovation Challenge

#### Deadline is October 27

USDA and Microsoft have launched a competition, called the Innovation Challenge, to help farmers and local food systems adapt to climate change. The Challenge is meant to encourage software developers to create applications that will use more than 100 years of USDA data on weather and climate, markets and consumer trends, and a wide range of other information to explore how our food system can achieve better food resiliency and help preserve existing farms and encourage new entry into agriculture. # Water-Quality Characteristics of Stormwater Runoff in Rapid City, South Dakota

Measurements collected by the USGS during 2013-2014 showed that concentrations of total suspended solids, metals, nutrients, and bacteria decreased in runoff to Rapid Creek when stormwater was routed through wetland channels in downtown Rapid City, South Dakota. However, chloride concentrations increased, likely due to the movement of salts deposited during prior runoff events. Publication available here.

# EPA – National Water Program 2015 Workplan

The *Workplan* lays out the actions that the EPA National Water Program plans to take in 2015 to implement the "EPA National Water Program 2012 Strategy: Response to Climate Change", which describes long-term goals for the management of sustainable water resources in light of climate change. # <u>Progress Report – Building Climate Change Resilience in Vulnerable Communities</u>

As part of his Climate Action Plan, President Obama established the State, Local, and Tribal Leaders Task Force on Climate Preparedness and Resilience in 2013. The Task Force's <u>recommendations</u> emphasized the importance of supporting communities that are disproportionately affected, including those facing economic or health-related challenges. The White House is currently releasing a <u>progress report</u> highlighting some of the key actions taken by the Administration in support of the Task Force's recommendations.

#### <u>DOE – Clean Energy Investment Initiatives</u>

The Department of Energy (DOE) announced several new and expanding initiatives as part of the Administration's Clean Energy Investment Summit, including the launch of a *Clean Energy Impact Investment Center* (CEII), which will work to make the Department's resources more readily available to the public, including to mission-driven investors. Clean energy finance is a key part of the solution set on climate change. This announcement builds off the Clean Energy Investment Initiative that was announced at the ARPA-E Summit in February, highlighting expanded private sector investment in solutions to climate change, including innovative technologies with breakthrough potential to reduce carbon pollution. EJSCREEN is an environmental justice screening and mapping tool that uses high-resolution maps combined with demographic and environmental data to identify places with potentially elevated environmental burdens and vulnerable populations. EJSCREEN's simple-to-understand color-coded maps, bar charts, and reports enable users to better understand areas in need of increased environmental protection, health care access, housing, infrastructure improvement, community revitalization, and climate resilience.
