Dear Governor Edwards:

I am happy to announce that, by virtue of the authority granted by the Administrator and effective today, I am delegating to the State of Louisiana and the Louisiana Department of Environmental Quality (LDEQ) the full authority to implement and enforce the National Emission Standard for Equipment Leaks (Fugitive Emission Sources) of Benzene under the National Emission Standards for Hazardous Air Pollutants (NESHAP) program in the State of Louisiana.

By virtue of the October 14, 1983, authority, EPA Region 6 delegated to the State of Louisiana and the LDEQ automatic delegation to implement the administrative and technical responsibilities for future NESHAP.

With the adoption of the Louisiana Emission Standards for Equipment Leaks (Fugitive Emission Sources) for Volatile Hazardous Air Pollutants by the Louisiana Department of Environmental Quality on May 20, 1985, and based on our review of these regulations, we have determined that the State's procedures and present resources are adequate for assuming full authority for the benzene NESHAP program, including enforcement activities. Therefore, the October 14, 1983, partial delegation provisions are replaced by the full delegation provisions which includes enforcement.

Since this full delegation becomes effective on the date of this letter, there is no requirement that the State notify EPA of its acceptance. Unless EPA receives a written notice of objection from the State of Louisiana within 10 days of the date of receipt of this letter, we will assume that the State of Louisiana and the LDEQ have accepted all of the terms of the delegation.
