
## Right to appeal

You have the right to appeal any final permit decision if you make an official comment during the comment period or participate in a public hearing. A public hearing is not planned at this time. The first appeal must be made to the Environmental Appeals Board.

# **EPA Plans to Modify an Existing Class II Permit**

The U.S. Environmental Protection Agency plans to modify what it calls a Class II injection well permit for SJX, LLC. 410 South Union Street, Traverse City, Michigan. The existing permit is for a well to be located north of Gladwin Rd and east of Twin Lakes Ave in Clare County, Michigan. EPA first issued a permit for this well on July 15, 2014. Since this well has not been drilled, the permit was set to expire July 15, 2015. SJX, LLC timely submitted a request to extend the permit for one year. Since the time of permit issuance, the northern long eared bat has been listed as threatened by the United States Fish and Wildlife Service. The proposed modifications restrict tree clearing activity to protect the northern long eared bat. Only the conditions proposed for modification are reopened for comment.

EPA is accepting comments from the public on the proposed modification (*see box, left*). The comment period, which ends **Tuesday March 1, 2016**, includes 30 days for comments as required by law, plus an additional three days for any delay caused by mailing.

During the comment period, you may ask EPA – in writing – to hold a formal public hearing (*see address, left*). Be sure to say specifically what issues you want to raise. EPA will hold a hearing if there is significant interest, and will publish a notice at least 30 days prior. You will have an opportunity to make oral comments or submit written comments. EPA will consider all comments, then issue a final decision along with a response to the comments.

The Safe Drinking Water Act requires EPA to regulate underground injection wells to protect underground sources of drinking water. Issuing permits is one way EPA does this. You can find the regulations governing underground injection wells at Title 40 of the Code of Federal Regulations, Parts 144 and 146.
