DATE OF THIS NOTICE: April 6, 2016

PURPOSE OF THIS NOTICE: The U.S. Environmental Protection Agency (EPA) is announcing its proposed modifications to the selected groundwater remedy under the Resource Conservation and Recovery Act, as amended (RCRA), for the Former UTI facility (Facility). EPA's proposed modifications modify EPA's groundwater cleanup goal for TCE and TCA by moving the point of compliance to the property boundary and requires compliance with an EPA-approved Monitoring Program, and requires the implementation of groundwater use restrictions on the plant property.

FACILITY DESCRIPTION: The Facility is located at 200 West 7th Avenue, Trappe, PA 19426. The facility has been used for the production of small-diameter specialty metal tubing and precision tubular parts since operations began in 1964. As a result of manufacturing at the Facility, groundwater at the Facility and off-site locations near the Facility became contaminated with volatile organic compounds (VOCs) and chromium. Contaminated groundwater has been remediated in accordance with the EPA's selected corrective measure described in the EPA's September 30, 1991 Final Decision and Response to Comments (FDRTC) and as required by a 1992 Administrative Order on Consent.

COMMENT PROCESS: Persons wishing to comment on EPA's proposed decision must submit comments to EPA within the 30 day comment period ending May 5, 2016. Interested persons may also request a public hearing on this proposed remedy. All comments and/or requests for a hearing must be submitted in writing via mail, fax, or email to the EPA Project Manager, Tran Tran, as listed above, and must be received prior to May 6, 2016. All comments will be considered in making a final decision.

FINAL DECISION: EPA will make a final decision after considering all comments, consistent with applicable RCRA requirements and regulations. If the decision is substantially unchanged from the one in this notice, EPA will issue a final decision and inform all persons who submitted written comments or requested notice of EPA's final determination. If the final decision is significantly different from the one proposed, EPA will issue a public notice explaining the new decision and will reopen the comment period.
