

Mrs. Toney:

Pursuant to the Data Requirements Rule (DRR) for the 1-Hour Sulfur Dioxide Primary National Ambient Air Quality Standard (NAAQS), EPA-HQ-OAR-2013-0711, published on August 21, 2015, each air agency is required to submit a list to the EPA by January 15, 2016 identifying all sources within its jurisdiction that have SO₂ emissions that exceeded the 2,000 tons per year (tpy) annual threshold during the most recent year for which emissions data are available. For the State of Alabama, calendar year 2014 emissions data was used as the threshold for source inclusion. Therefore, the State of Alabama submits the following DRR subject source lists:
