The Guam Environmental Protection Agency is pleased to submit to you a list that identifies all emission sources within our jurisdiction that have SO₂ emissions that exceeded the two thousand (2,000) tons per year (tpy) annual threshold for which the most recent which emissions data are available. The only area on Guam with emission sources currently over the 2,000 tpy annual emissions threshold is the Cabra/Piti Non-Attainment Area.
