

# National Standard LLC, Mount Joy Wire Impoundment, Mount Joy, PA

## Public Notice

**DATE OF THIS NOTICE:** August 11, 2016

**PURPOSE OF THIS NOTICE:** The U.S. Environmental Protection Agency (EPA) is announcing its proposed decision that Corrective Action is Complete and land use restrictions are required under the Resource Conservation and Recovery Act, as amended (RCRA), for the National Standard LLC, Mount Joy Wire Impoundment, Mount Joy, PA facility (Facility). The proposed remedy consists of operation, maintenance and monitoring of the impoundment cap, groundwater abatement system, and groundwater monitoring system; and institutional controls to restrict activities at the Facility. EPA is also issuing a draft permit for post-closure care of the facility.

**FACILITY DESCRIPTION:** The Facility is located at 1000 East Main Street, Mount Joy, PA. The Facility occupies approximately 4 acres at the Mount Joy Wire Corporation property. The impoundment received waste from the Mount Joy Wire manufacturing plant from 1978 to 1988. The impoundment was closed in 1990, when waste material was removed and the area was covered with a multi-layer cap.

**COMMENT PROCESS:** Persons wishing to comment on EPA's proposed decision or draft permit must submit comments to EPA within the 45-day comment period **ending September 26, 2016**. Interested persons may also request a public hearing on this proposed decision or draft permit. All comments and/or requests for a hearing must be submitted in writing via mail, fax, or email to the EPA Project Manager, Maureen Essenthier, as listed above, and must be received **prior to September 26, 2016**. All comments will be considered in making final decisions.

**FINAL DECISIONS:** EPA will make final decisions after considering all comments, consistent with applicable RCRA requirements and regulations. If the decisions for Corrective Action or the permit are substantially unchanged from those proposed in this notice, EPA will issue a final decision and final permit, and inform all persons who submitted written comments or requested notice of EPA's decisions. If the final decision or permit is significantly different from those proposed, EPA will issue a public notice explaining the new decisions and will reopen the comment period.
