## **MEMORANDUM**

SUBJECT: Opt-Out Notice Designating EPA as the 'Initial Recipient' for One or More

NPDES Data Groups

The U.S. Environmental Protection Agency (EPA) recently promulgated a final rule to modernize Clean Water Act reporting for municipalities, industries, and other facilities by converting to an electronic data reporting system. This final rule will require regulated entities and state and federal regulators to use existing, available information technology to electronically report data required by the National Pollutant Discharge Elimination System (NPDES) permit program instead of filing written paper reports.<sup>1</sup>

Under the final rule, NPDES-regulated entities are required to submit NPDES program data to the designated Initial Recipient, as defined in 40 CFR 127.2(b). For this rule, the term "Initial Recipient" means the governmental entity, either the state or EPA, who first receives the NPDES program data listed in Appendix A to 40 CFR part 127. The Initial Recipient designation is made separately by each state and by each NPDES Data Group, which is defined in 40 CFR 127.2(c). Identification of the Initial Recipient for each NPDES Data Group is included as a new NPDES permit standard condition [see 40 CFR 122.41(1)(9)].

This rule requires each authorized NPDES program to decide the NPDES Data Groups for which they wish to be the Initial Recipient of electronic NPDES information from NPDES-regulated entities. The final rule uses an 'opt-out' approach such that authorized NPDES programs must provide notice to EPA if they wish for EPA to be the initial recipient for one or more of their NPDES Data Groups. These 'opt-out' notices should be sent to EPA no later than April 19, 2016.
