Air Monitoring Summary

Camp Minden Area I

Start Time: 11-16-2016 1800 - End Time: 11-17-2016 1800

November 17, 2016 – EPA monitored for seven ambient air pollutants over a 24 hour period at the Camp Minden Area I air monitoring location. The seven pollutants included carbon monoxide, carbon dioxide, nitrogen oxide, nitrogen dioxide, nitrogen oxides, sulfur dioxide, and fine particulates. Over the 24 hour period, each of these pollutants were detected below EPA’s National Ambient Air Quality Standards or the action benchmark when an air quality standard had not been previously established.

Below is a summary of Camp Minden Air Monitoring Data collected at the location referenced above. The table contains a detailed listing of the following:

- 1 Average reading of each analyte from November 16, 2016 1800 through November 17, 2016, 2016 1800
- 2 Highest measurement of each analyte from November 16, 2016 1800 through November 17, 2016 1800

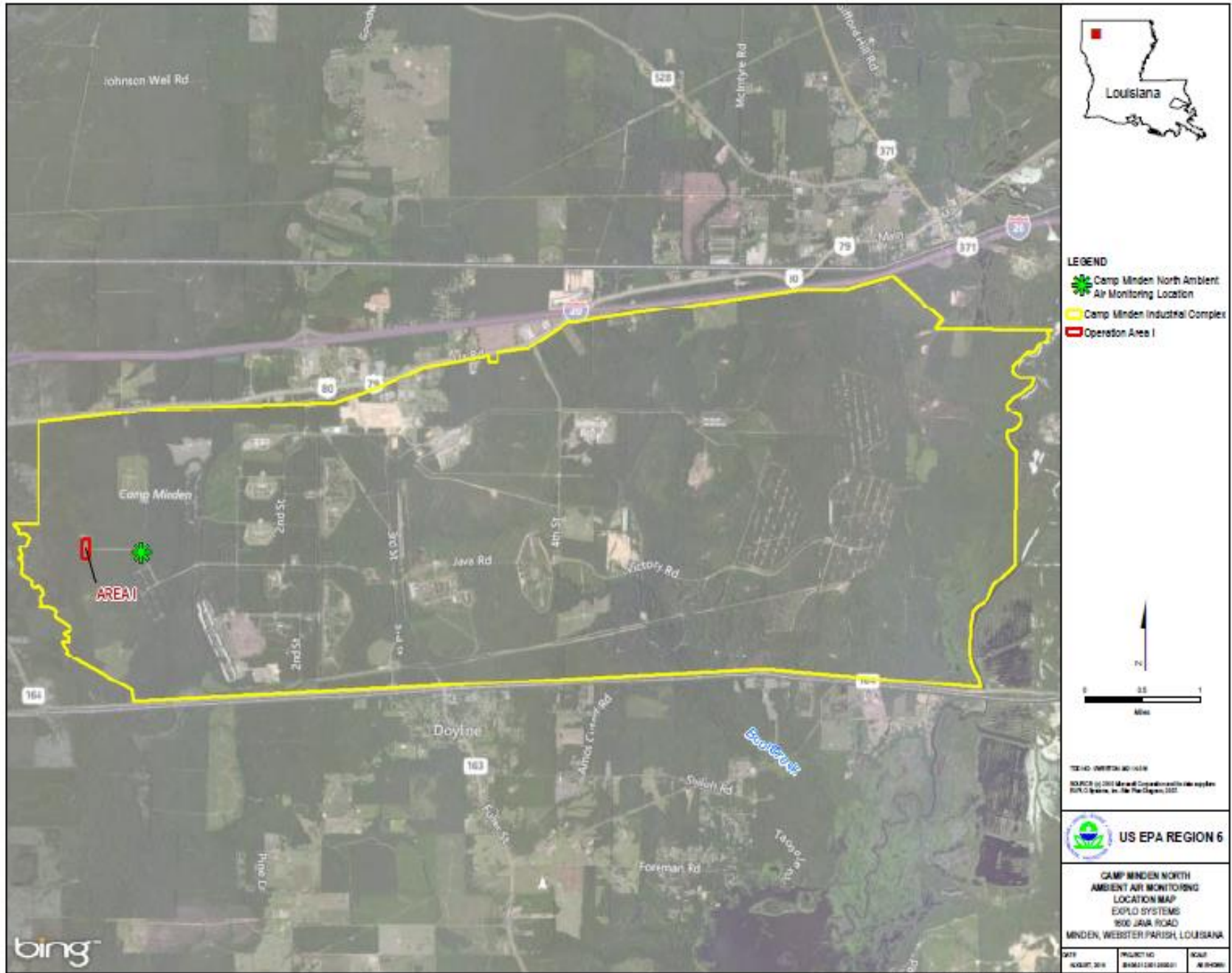

**The monitoring database has been validated for calendar day 11/17/16 (through 00:00 11/18/16 CST). All analyzers were operating normally. Logger was reset at 0601 and 1601 CST for Modbus. The weather station logger lost communications after 1730 CST.

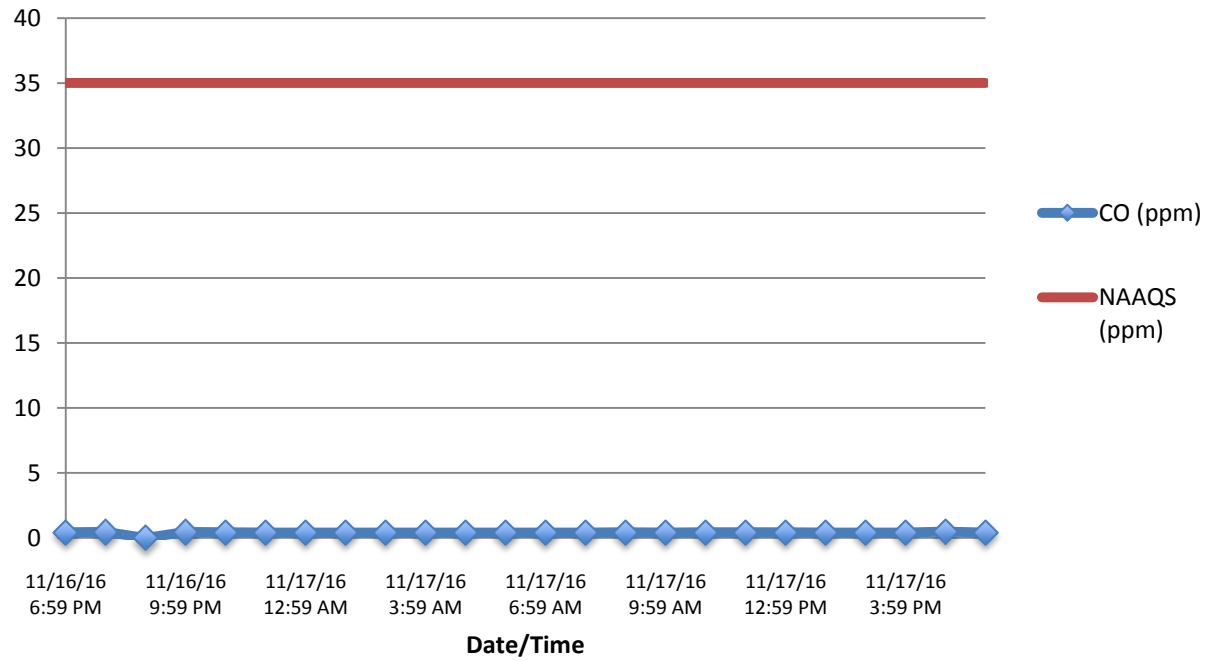

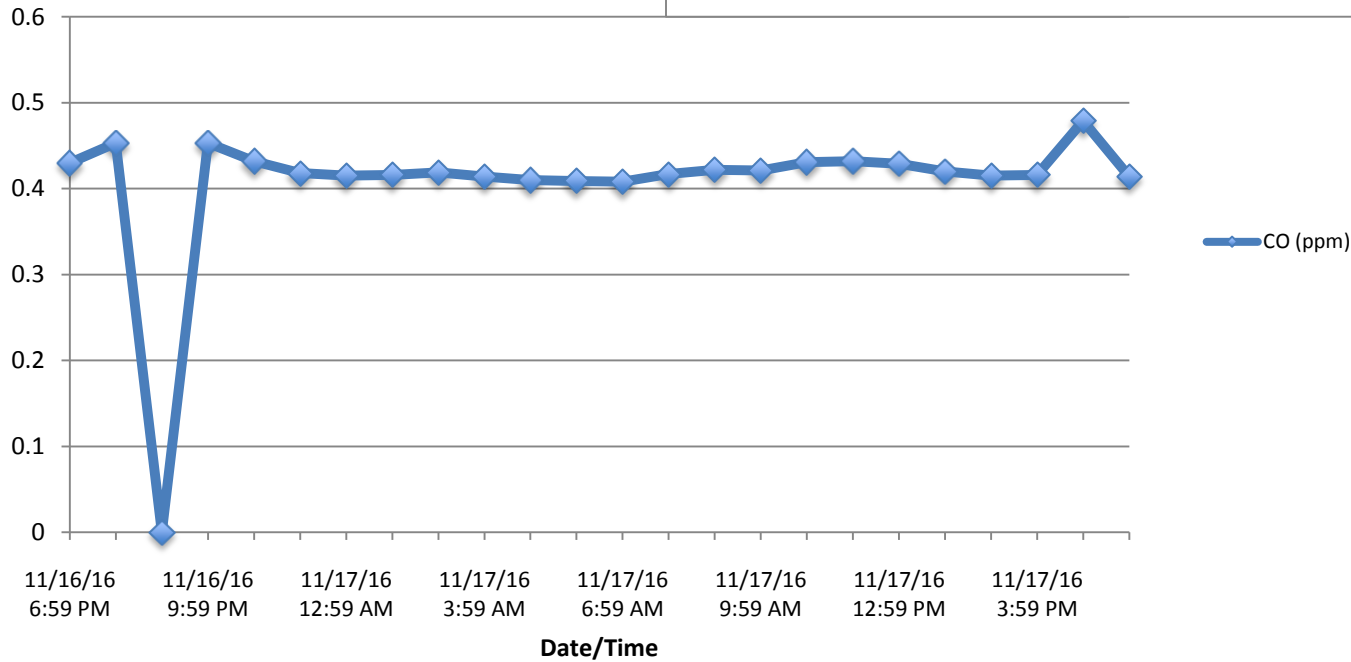
Camp Minden Area I Station Location Map for 17 November 2016



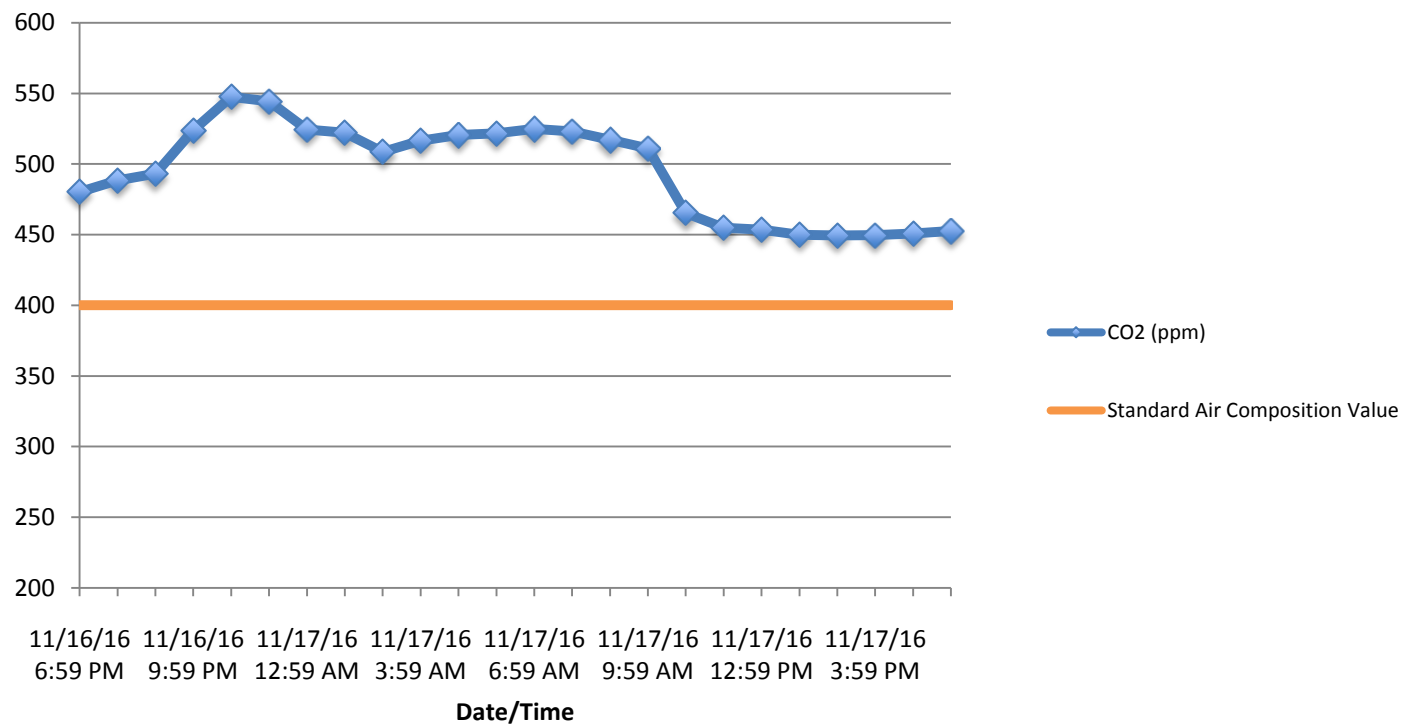
Hourly Averages CO (ppm)



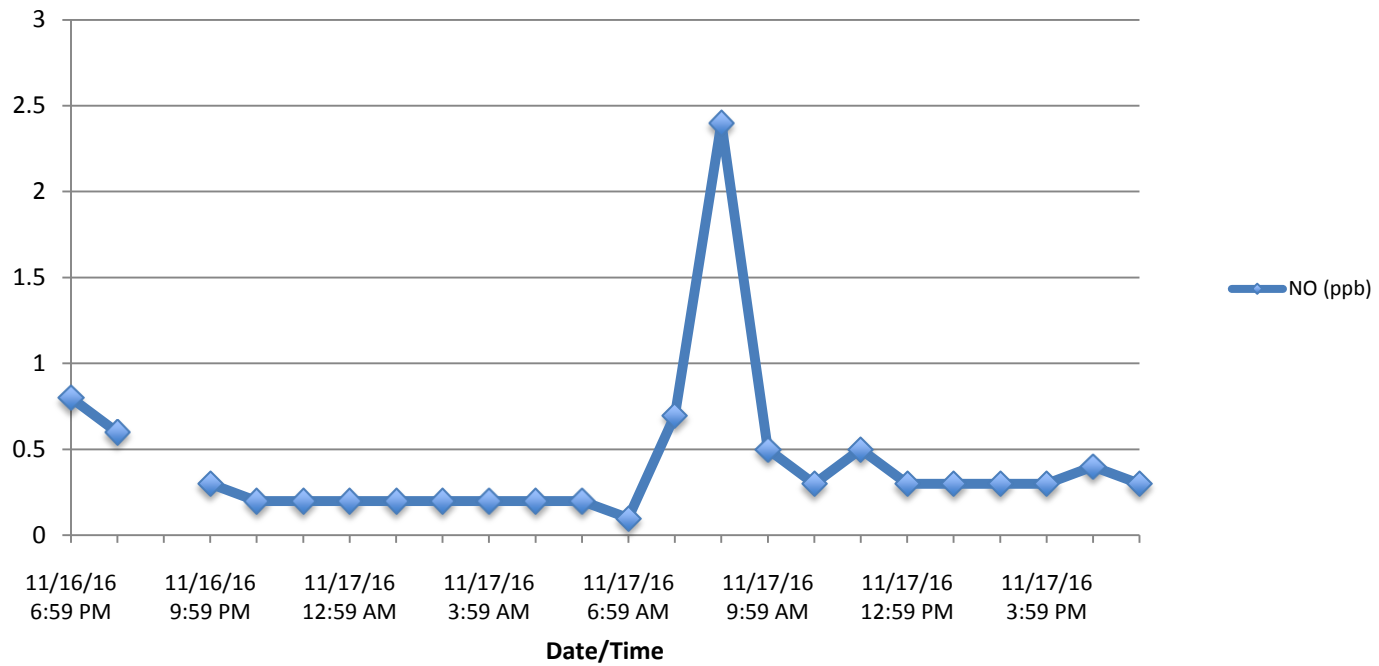
Hourly Averages CO (ppm) NAAQS 35 ppm



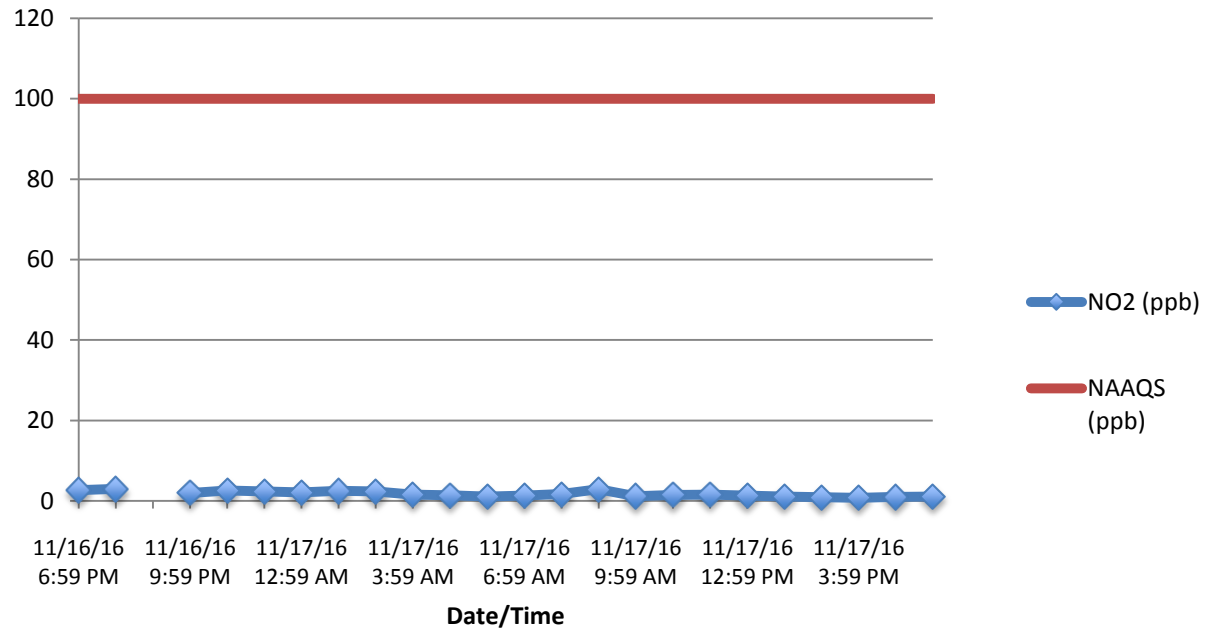
Hourly Averages CO2 (ppm) For Monitoring Only



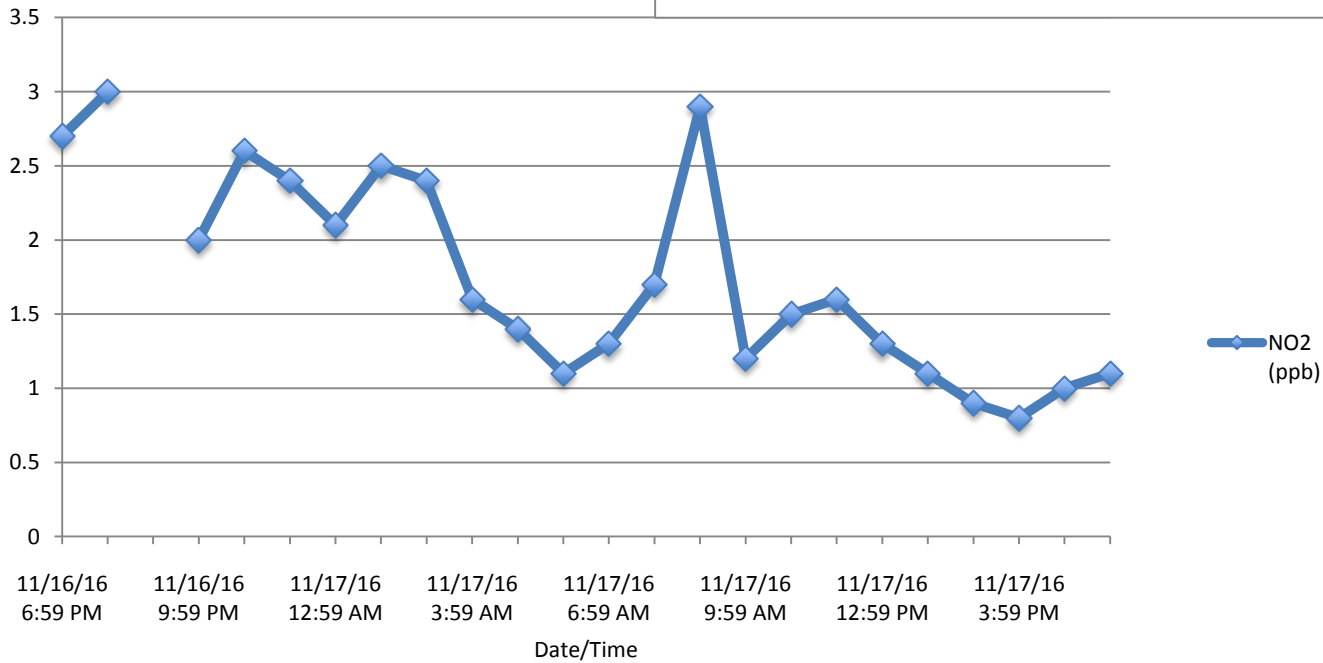
Hourly Averages NO (ppb) For Monitoring Only



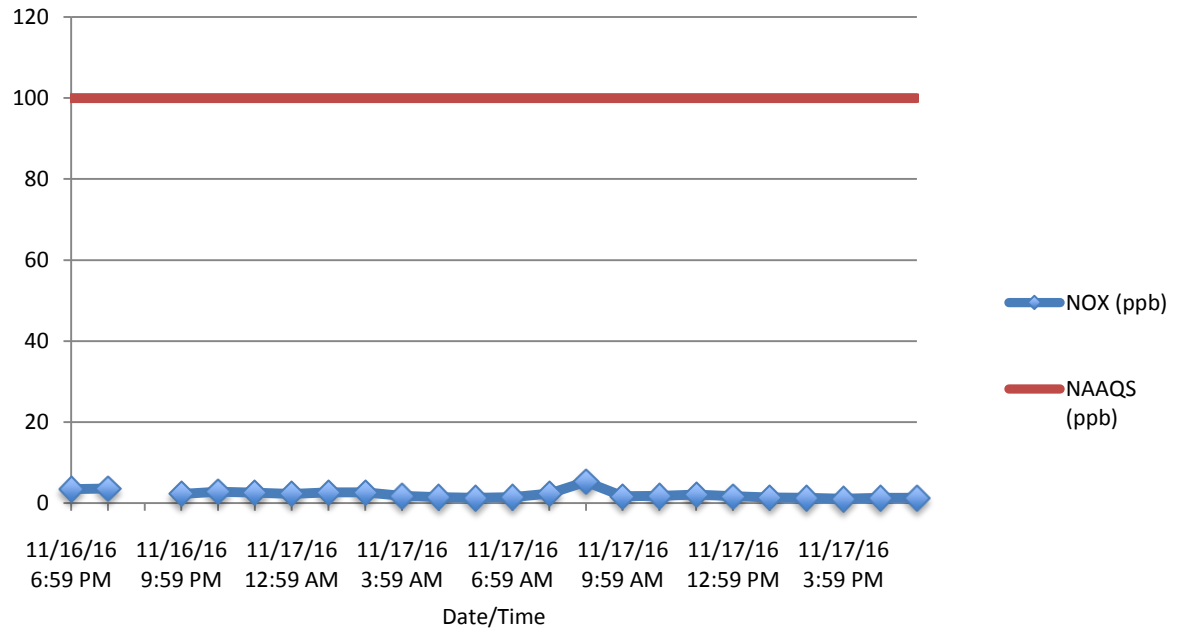
Hourly Averages NO2 (ppb)



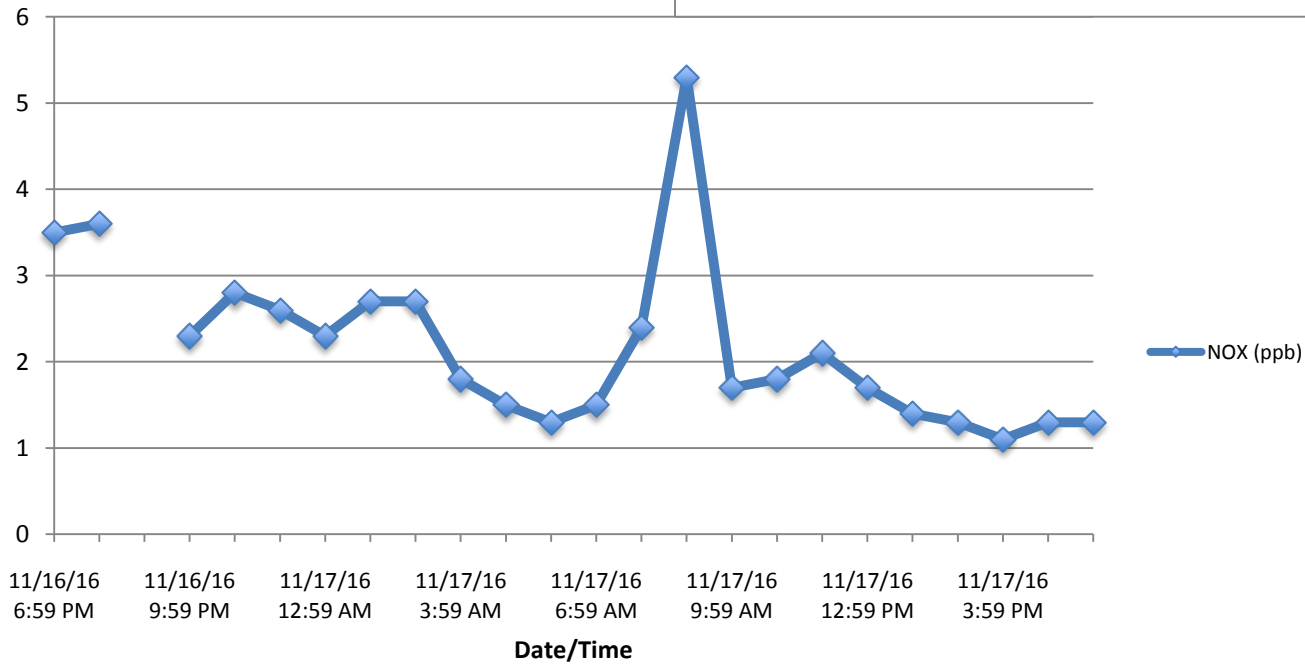
Hourly Averages NO2 (ppb) NAAQS 100 ppb



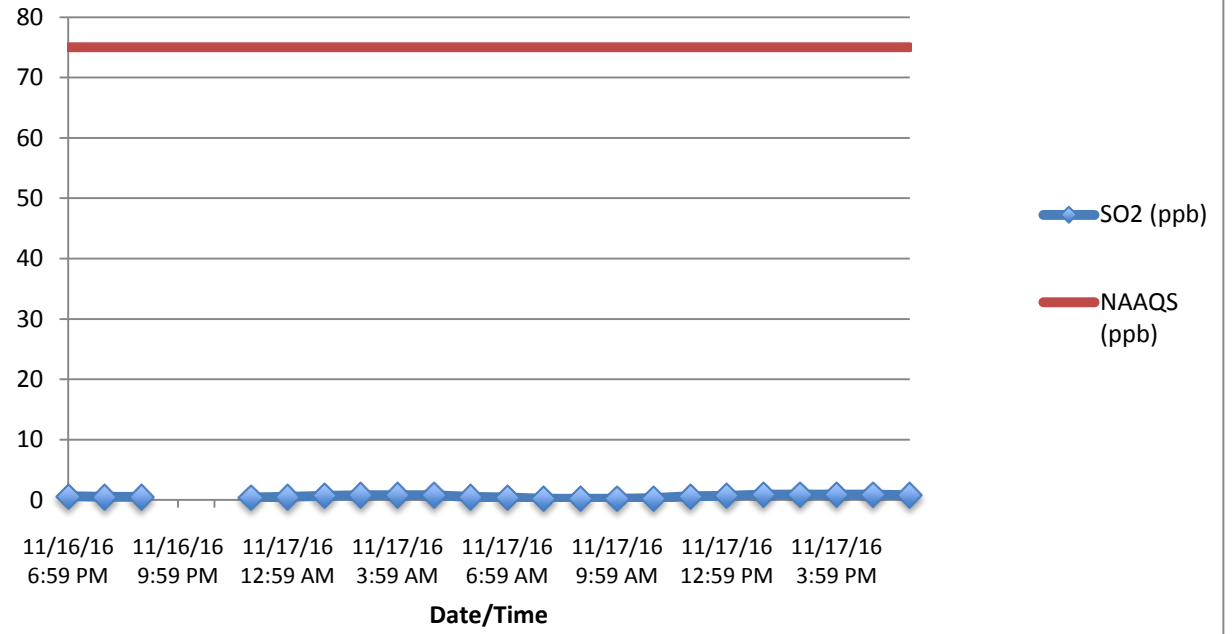
Hourly Averages NOX (ppb)



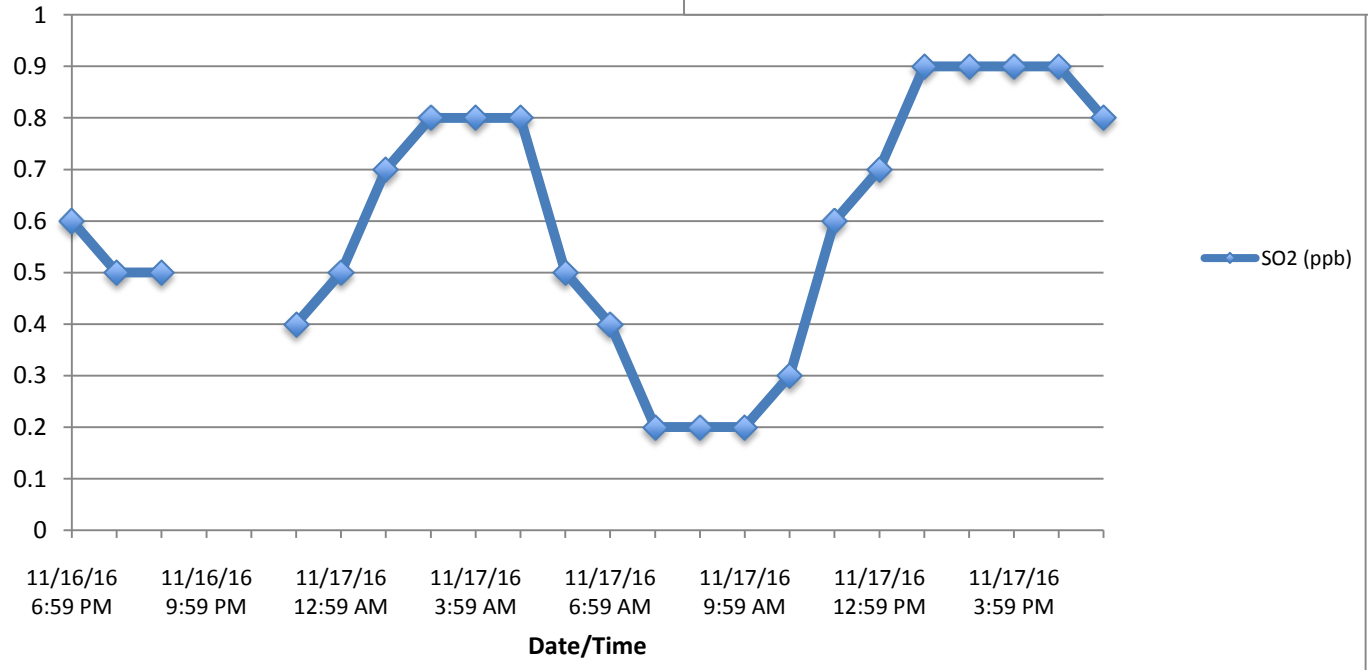
Hourly Averages NOX (ppb) NAAQS 100 ppb



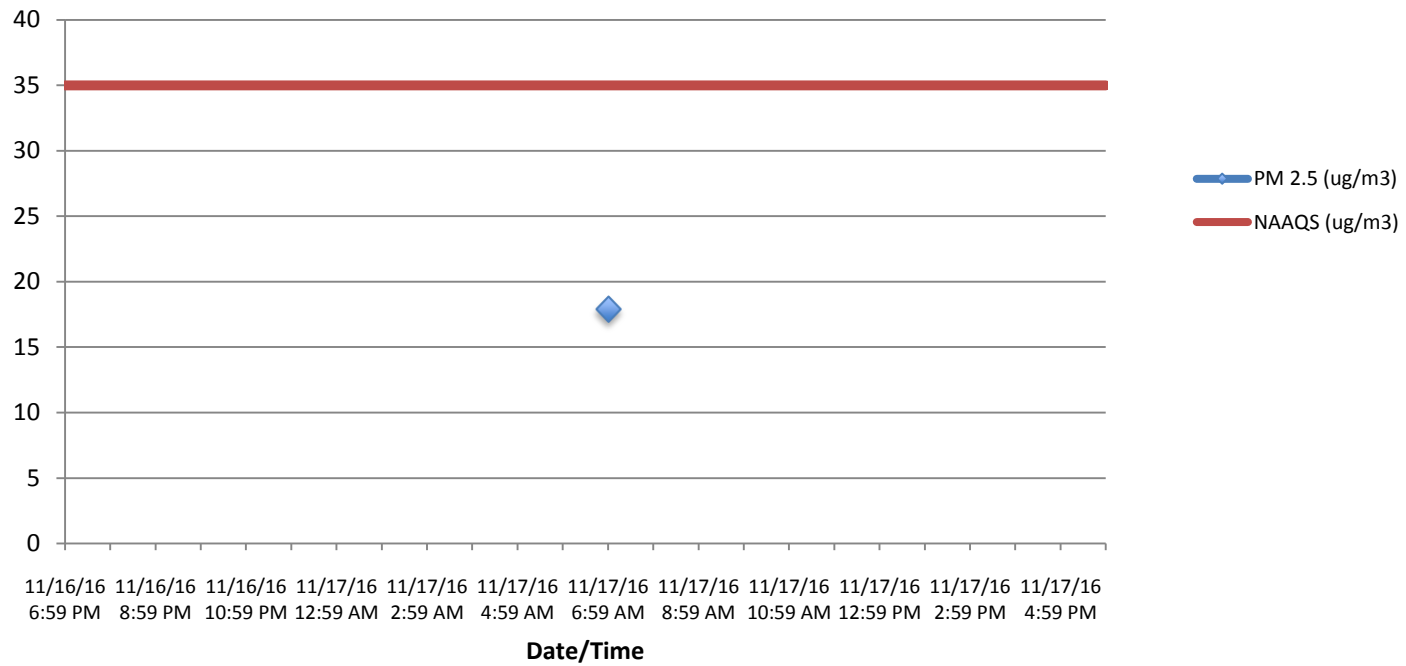
Hourly Averages SO2 (ppb)
