Regional School IPM Highlights for FY2016

Update to the Pesticide Program Dialogue Committee - November 2016

Headquarters Guidance

Regional activities in FY2016 were guided by the Agency's overall strategic plan for school IPM. The School IPM Roundtable was the keystone event for the Agency's School IPM program for the year. The purpose of the Roundtable was to secure the endorsement of IPM as the preferred approach for managing pests in schools by national organizations with influence in the school community, and obtain commitments from the participants to disseminate their endorsement and related school IPM information to their memberships and affiliated organizations.

In support of the Roundtable, the Regions were asked to reach out to the state chapters of participants to provide background on the Agency's School IPM program, establish a general dialog on the Roundtable, and convey how the state affiliates would be receiving IPM information through their national leadership. To assist in this effort, the Regions were provided presentations, background documents, contact lists, and talking points.
