<u>PURPOSE:</u> The purpose of this notice is to state the EPA's intention to reissue a National Pollutant Discharge Elimination System (NPDES) permit under the authority of Section 402 of the Clean Water Act.

<u>ACTIVITY</u>: Potential discharge of finished water from the Hardin Water Treatment Plant to the Bighorn River. The facility infiltrates and evaporates its wastewater in a lagoon system and only plans to discharge in case of emergency. The facility is located adjacent to the Crow Reservation, Big Horn County, Montana, but the lagoon and potential discharge location is within the Crow Reservation. Authorization for discharge is limited to only those outfalls specifically listed in the permit.

PUBLIC COMMENTS: Comment period ends 30 calendar days after the date of publication of this notice. Comments must be directed to: Lisa Kusnierz (8MO), U.S. Environmental Protection Agency, Region 8, 10 West 15th Street, Suite 3200, Helena, Montana 59626. All comments received prior to the end of the comment period will be considered in the formulation of any final permit determination, and will be part of the administrative record. Any commenter may request a public hearing and the EPA will hold a hearing if the response to this notice indicates significant public interest. The EPA is also requesting comments on the possible adverse effects of reissuing the permit on historic properties and/or cultural resources in the area.
