Re: Sign-up Letter for EPA Ozone Advance Program

Dear Ms. Bunte:

The El Paso Metropolitan Planning Organization (MPO) would like to participate in the Ozone Advance Program to improve the air quality here in the Paso del Norte (PDN) air quality basin. Please consider this "sign-up letter" as our request to participate in the Ozone Advance Program.

The El Paso MPO, through the Air Improvement Resources Group (the AIR Group) of El Paso MPO, serves as the air quality planning and improvement body for the PDN region, which the region consists of El Paso, Texas, Dona Ana County, New Mexico of the U.S. and Ciudad Juarez, Chihuahua of Mexico.

We wish to join this partnership with EPA to preserve and improve the air quality in the region and we meet the following program eligibility criteria:

- (1) El Paso County, Texas and Dona Ana County, New Mexico are currently in attainment of both the 1997 8-hour or the 2008 ozone National Ambient Air Quality Standards (NAAQS).
- (2) The metropolitan planning study area consists of the U.S. portion of the Paso del Norte (PDN) region which encompasses the city of El Paso and El Paso County, Texas and portions of Dona Ana and Otero Counties, New Mexico.
- (3) There are eleven (11) ozone air monitors located in the metropolitan planning study area with six (6) of them in the El Paso Metropolitan Statistical Area (El Paso MSA) and five (5) in the Dona Ana County. The following air monitors reflect the air quality in the PDN:

(4) Existing emissions inventory reporting requirements have been met by the Texas Commission on Environmental Quality (TCEQ) and New Mexico Environmental Department (NMED).

We understand that our efforts under Ozone Advance may benefit the PDN by potentially:

- · Reducing air pollution in terms of ozone as well as other air pollutants,
- Ensuring continued healthy ozone levels,
- Maintaining the ozone National Ambient Air Quality Standards (NAAQS),
- Helping avoid violations of the NAAQS that could lead to a future nonattainment designation,
- Increasing public awareness about ozone as an air pollutant.

Our goal is to implement measures and programs to reduce ozone in the PDN in the near term. We agree that it is in our best interest to work together and in coordination with stakeholders and the public to proactively pursue this goal.
