#### **Air Monitoring Summary**

Camp Minden Area I
Start Time: 11-28-2016 1800 - End Time: 11-29-2016 1800

November 29, 2016 – EPA monitored for seven ambient air pollutants over a 24 hour period at the Camp Minden Area I air monitoring location. The seven pollutants included carbon monoxide, carbon dioxide, nitrogen oxide, nitrogen oxides, sulfur dioxide, and fine particulates. Over the 24 hour period, each of these pollutants were detected below EPA's National Ambient Air Quality Standards or the action benchmark when an air quality standard had not been previously established.

Below is a summary of Camp Minden Air Monitoring Data collected at the location referenced above. The table contains a detailed listing of the following:

- 1 Average reading of each analyte from November 28, 2016 1800 through November 29, 2016, 2016 1800
- 2 Highest measurement of each analyte from November 28, 2016 1800 through November 29, 2016 1800




\*\* The monitoring database has been validated for calendar day 11/29/16 (through 00:00 11/30/16 CST). All analyzers were operating normally. PM2.5 reading spiked to 40 ug/m3 at 0900 CST. Trailer temperatures were varying during the morning hours, because the station was unattended due to no destruction activity during day. Data were considered valid, but may have been affected by temperature variation. The logger was reset at 0701 CST to clear Modbus communication.






#### **Camp Minden Area I Station Location Map for 29 November 2016**
















### Hourly Averages NO2 (ppb) NAAQS 100 ppb


