Dear Mr. Black:

Chevron is submitting this quarterly progress report in accordance with Section 19.b of the November 2006 Administrative Order on Consent (AOC), for the time period from January 1 to March 31, 2012. The progress and status of the various activities performed for this time period are presented herein.

- 1. Chevron sent the following correspondence to the United States Environmental Protection Agency (USEPA) in the first quarter of 2012:

 - A phone call and email dated January 9, 2012 discussing arrangements for a meeting at USEPA Region 5 headquarters on March 1, 2012 to discuss the findings and recommendations provided within the Five Year Corrective Measures Implementation Review.

- 5. The following monitoring and assessment activities were conducted in the first quarter of 2012:
 - Bi-monthly fluid level gauging was performed across the facility, Hooven, Southwest Quad, and Gulf Park on January 27 and March 28, 2012.
 - The installation of an interior and exterior groundwater monitoring well along the southern barrier wall near Gulf Park was completed on March 15, 2012.
 - Repairs to the southern section of the sheet pile barrier wall and bank stabilization measures along the East Bank of the Great Miami River near Gulf Park was completed on March 15, 2012.
 - Modifications to the Gulf Park bioventing system which included the installation of 14 additional biovent wells south of the current system began on March 19, 2012.

Planned Activities - Second Quarter 2012

- 1. The following monitoring and assessment activities are planned for the second quarter of 2012:
 - Bi-monthly fluid level gauging within the shallow monitoring network across the former refinery and Gulf Park in May 2012.
 - Weekly high-grade, HSVE, and Gulf Park systems trigger level monitoring.
 - Semiannual groundwater monitoring of the main-site barrier wall monitoring wells.
 - Semiannual groundwater monitoring of the Southwest Quad point of compliance and sentinel monitoring well network.
 - Semiannual groundwater monitoring of the lysimeters, facility, Hooven, and Southwest Quad monitoring wells.
- 2. Review and validation of the laboratory analytical data will continue to be conducted as necessary.
