

**Tate Access Floors (Formerly: USG Interiors, LLC) - (EPA ID PAD000800508)**  
**Public Notice**

**DATE OF THIS NOTICE: March 14, 2017**

**PURPOSE OF THIS NOTICE:** The U.S. Environmental Protection Agency (EPA) is announcing its proposed decision of Corrective Action Complete with Controls under the Resource Conservation and Recovery Act (RCRA), as amended, for Tate Access Floors (Facility) (EPA ID PAD000800508).

**FACILITY DESCRIPTION:** The Tate Access Floors facility is a 15 acre parcel located in Red Lion, in Windsor Township, Pennsylvania. The Tate Access Floors facility is now used for the production of panels for flooring systems, which facilitate access for sub-floor electrical and utility services, particularly for applications involving computer equipment. The facility conducted soil and groundwater sampling while in the PADEP's Land Recycling and Environmental Remediation Standards Act, 35 P.S. Sections 6026.101 *et seq.*, program.

**COMMENT PROCESS:** Persons wishing to comment on EPA's proposed decision must submit comments to EPA within the 30 day comment period ending April 14, 2017. Interested persons may also request a public hearing on this proposed remedy. All comments and/or requests for a hearing must be submitted in writing via mail, fax, or email to the EPA Project Manager, Ms. Catheryn Blankenbiller, as listed above, and must be received prior to April 14, 2017. All comments will be considered in making a final decision.

**FINAL DECISION:** EPA will make a final decision after considering all comments, consistent with applicable RCRA requirements and regulations. If the decision is substantially unchanged from the one in this notice, EPA will issue a final decision and inform all persons who submitted written comments or requested notice of EPA's final determination. If the final decision is significantly different from the one proposed, EPA will issue a public notice explaining the new decision and will reopen the comment period.
