



Social Trust*

- Social Trust
 - The willingness to rely on those who have the responsibility for making decisions and taking actions related to the management of technology, the environment, medicine, or other realms of public health and safety.
 - Government
 - Schools
 - Doctors

Social Trust

- What supports social trust?
 - Shared similar values
 - Use similar rhetoric or language
 - Look like you
 - Perceived shared live experiences
 - Social connections
 - A history of trust





Community Engagement with Minority Communities

- Community engagement to to build trust/relationships
 - Tailored to that community
 - Not homogenous entities
 - Respectful
 - Treat the community as equals
 - Humility
 - Committed
 - Long term investment
 - Honest
 - Real access to power
 - Symmetrical trust
 - Partners

Structural Changes

- Develop relationships with multiple community leaders
- Diversity in agency
 - People from community
- Need to know the community history with government agencies
 - All government agencies
