Analysis of NO_x Budget Trading Program Units

Brought into the CAIR NO_x Ozone Season Trading Program

Background

EPA and states have worked together on regional programs to control long-range transport of ozone for more than 10 years. The Ozone Transport Commission (OTC) NO_x Budget Trading Program, a regional trading program to reduce summertime NO_x in the northeast, was in place from 1999-2002. The OTC program was replaced by the NO_x SIP Call NO_x Budget Trading Program (NBP) which started in 2003 and ran through 2008. Twenty states and the District of Columbia were in the NBP¹. The NBP was part of the NO_x SIP Call which is still in effect and includes requirements to reduce NO_x emissions from large combustion sources.

The combustion sources subject to the NBP included large industrial boilers and turbines with a maximum rated heat input capacity greater than 250 MMBTU/hr (non-electric generating units, or non-EGUs) and electric generating units (EGUs) greater than 25 MW. The NO_x SIP Call states used the NBP to comply with the NO_x SIP Call requirements for these large combustion sources². EPA stopped administering the NBP after the 2008 ozone season control period activities, and states used another mechanism to comply with the NO_x SIP Call requirements.

One mechanism states subject to the NO_x SIP Call used to continue to comply with the NO_x SIP Call was expanding the applicability of the Clean Air Interstate Rule (CAIR) NO_x ozone season trading program to include all units subject to the NBP. Fourteen states chose to expand the CAIR NO_x ozone season applicability in this way, while six states chose not to expand the applicability and instead to meet their NO_x SIP Call obligations in other ways. When a state expanded the applicability of the CAIR NO_x ozone season trading program, the CAIR NO_x ozone season budget in that state was increased to account for these additional sources by the same amount that was allowed under the NBP. NBP budgets for non-EGUs generally reflect a 60 percent reduction of uncontrolled emissions.

In preparing the Transport Rule proposal, EPA analyzed whether the expansion of the CAIR NO_x ozone season trading program applicability to include all NBP units in certain states

actually resulted in NO_X emission reductions in the ozone season in order to decide whether to propose to allow this option to continue in the Transport Rule.

Analysis

EPA analyzed the effect of having the large non-EGU units in the NBP and the CAIR NO_X ozone season trading program and evaluated whether or not emissions from this group of units were reduced as a result of their inclusion in those trading programs.

The units evaluated began reporting emissions one year prior to their state's entry into the NBP. For states that were part of the OTC NO_X Budget Trading Program, the NBP started in 2003. For all other NBP states except Missouri, the NBP requirements took effect in 2004. Sources in eastern Missouri began complying with the NBP in 2007. For this analysis, emissions from 2004 and 2009 were compared. The unit-specific emissions and operating data for 2004 and 2009 are found in the appendices. The total amount added to state NBP budgets for non-EGUs for the 14 states³ that included these non-EGUs in the CAIR NO_X ozone season trading program is 47,297 tons. This amount of allowances was added to the CAIR NO_X ozone season trading program budget. In 2009, the additional units emitted less than half of the amount of allowances added to the CAIR NO_X ozone season budgets for them. EPA has determined that these units as a group did not reduce emissions as a result of the NBP or through their inclusion in the CAIR NO_X ozone season trading program, and their current emission rates are nearly identical to what they were for the NBP. Moreover, these units as a group had allowances that they did not need for compliance and that were available for trading to other affected units. Table 1 summarizes the overall emissions and emission rates of all of these units. Emissions were lower in 2009 as compared to 2004, but the majority of that reduction is attributable to overall reduced operating hours. The weighted average emission rate in 2009 was almost identical to the weighted average emission rate in 2004 when the NBP started.

The total NO_x emissions for 2009 were 20,424 tons, which is 43% of the budget amount that was added for them. As shown in Table 2, emissions were less than the additional budget amount in all of the states affected.

The 26,873 allowances not used by non-EGUs for compliance in 2009 are available for the sources to trade to other affected units allowing them to emit. As a group, these large non-EGUs did not reduce their NO_x emissions or their NO_x emission rates as a result of their inclusion in the CAIR NO_x ozone season program.

Summary and Conclusion

The NO_X SIP Call continues to apply and those states must ensure that the state budget is met. The proposed Transport Rule does not include non-EGUs and does not allow states to modify the applicability of the Transport Rule to include them like they could in CAIR. The non-EGUs will continue to monitor and report NO_X emissions in the ozone season as required by the NO_X SIP Call. EPA will evaluate whether additional controls for these are warranted in a future rulemaking.
