Total 8,116,000 BHP-HRS

- 4. Total NOx emissions from the facility shall not exceed 95 TPY.
- 5. The facility shall submit quarterly reports, and cumulative totals for the year to demonstrate compliance with condition #3 and #4. The reports shall contain the bhphrs and NOx emission in pounds per hour and tons per year.
- Reboiler #1 and #2 shall comply with the presumptive RACT emission limitation for installation, maintenance and operation of the sources in accordance with manufacturers specifications.
 - 7. This RACT approval applies to the emission of NOx and VOC pollutants only. Emission of other pollutants, including criteria pollutants, shall be governed by the existing Plan Approvals, Operating Permits, and applicable requirements and other Rules and Regulations of the Department which are incorporated herein by reference and made part of this permit.
- 8. Columbia Gas Transmission Corp. shall implement the RACT Plan by May 31, 1995, as defined in 25 PA Code Section 129.91. The implementation schedule may be extended only upon the execution and approval of a Consent Decree between Columbia Gas Transmission Corp. and the Department of Environmental Resources.
