

In accordance with provisions of the Air Pollution Control Act, the Act of January 8, 1960, P. L. 2119, as amended, and with Chapter 127 of the Rules and Regulations of the Department of Environmental Resources, the Department on **JUL 25 1996** approved plans for achieving compliance by the above indicated air contamination source(s) with the requirements of 25 Pa Code Section 129.91 through 129.95.

The operating permit is subject to the following conditions:

1. The facility is to be operated in accordance with the plan submitted with the application (as approved herein).
2. The facility shall implement the RACT plan no later than May 31, 1995.

- ~~2. The facility shall use applicable paint coatings in compliance with 25 Pa Code Section 129.53, Table 1.~~
- ~~4. The facility shall maintain daily records of all paint coatings used in accordance with 25 Pa Code Section 129.95. Records shall be made available to the Department upon request.~~
5. The facility shall maintain daily records of all mineral spirit usage in accordance with 25 Pa Code Section 129.95. Records shall be made available to the Department upon request.
6. The facility shall notify the Department when changes are made to higher flashpoint mineral spirits (as discussed in the RACT proposal). Changes in solvent shall be noted by the Department and incorporated into the RACT operating permit.
7. Foundry VOC emissions shall not exceed 5.1 lbs VOC per ton of hot metal (based on a 24 hour average).
8. The facility shall show compliance with condition #7 by maintaining monthly records of Foundry VOC containing material purchases, and tons of metal melted.
9. Sources identified in this proposal shall be maintained in accordance with manufacturer's recommendations, and in a manner consistent with good air pollution control practices.
- ~~10. Any information required to be submitted as part of the above conditions shall be submitted to the attention of Mr. Devendra Verma, Engineering Services Chief, Air Quality Control, Northwest Regional Office, 230 Chestnut St., Meadville, Pa 16835.~~
- ~~11. This RACT approval applies to the emission of NOx and VOC pollutants only. Emission of other pollutants shall be governed by the existing Plan Approvals, Operating Permits, and applicable requirements of the Rules and Regulations of the Department. Such approval, permits, and requirements are incorporated herein by reference and made part of this permit.~~
