PURPOSE OF THIS NOTICE: The U.S. Environmental Protection Agency (EPA) is announcing its proposed remedy of Corrective Action Complete with Controls under the Resource Conservation and Recovery Act, as amended (RCRA), for the Former Dana Corporation facility (Facility).

FACILITY DESCRIPTION: The Facility is located at Robeson and Weiser Streets, Reading, Berks County, PA 19612. The Facility manufactured automobile and truck frames from 1920 until 2000. Hazardous wastes generated at the facility included ignitable waste (D001), toxicity characteristic wastes (D007 and D008) and spent solvents (F001, F005 and F003). The contamination consisted primarily RCRA metals, PCBs, and volatile organic compounds impacted soil and RCRA metals and volatile organic compounds contaminated groundwater. Contaminated soils were excavated and disposed off-site. Contaminated groundwater was remediated from 1993 to 2006. The Facility attained the Act 2 Statewide Health Standards for soil and site-specific standards for groundwater through the Pennsylvania Land Recycling Program.

COMMENT PROCESS: Persons wishing to comment on EPA's proposed decision must submit comments to EPA within the 30-day comment period ending September 21, 2017. Interested persons may also request a public hearing on this proposed remedy. All comments and/or requests for a hearing must be submitted in writing via mail, fax, or email to the EPA Project Manager, Tran Tran, as listed above, and must be received prior to September 22, 2017. All comments will be considered in making a final decision.

FINAL DECISION: EPA will make a final decision after considering all comments, consistent with applicable RCRA requirements and regulations. If the decision is substantially unchanged from the one in this notice, EPA will issue a final decision and inform all persons who submitted written comments or requested notice of EPA's final determination. If the final decision is significantly different from the one proposed, EPA will issue a public notice explaining the new decision and will reopen the comment period.
