

Special Conditions

3. This RACT Operating Permit approves the Reasonably Available Control Technology (RACT) proposal submitted by Fleetwood Folding Trailers, Inc. (Fleetwood) for its travel trailer manufacturing facility in the Borough of Somerset, Somerset County.
4. The Approval does not waive, either expressly or by implication any existing or previous Plan Approval or Operating Permit Conditions or requirements issued to the Owner/Operator of the source.
- ~~5. All coatings used at this facility shall have a VOC content equal to or less than 2.50 lbs/gallon (minus water) in accordance with 25 Pa. Code Section 129.95, Table 1, 10, (5).~~
6. Fleetwood shall maintain the appropriate daily records of all coatings purchased and consumed, and the inventory on hand in accordance with the recordkeeping requirements of 25 Pa. Code Section 129.95 to verify compliance with the emission limit in Condition 5, above. Records shall also be kept for all other VOC containing materials. These records shall be maintained on file for a period of not less than two years and made available to the Department upon request.
7. Fleetwood shall submit the final results of the material substitution study to the Department no later than May 31, 1995. Included in this report shall be a discussion of the findings regarding the investigation of using High Volume Low Pressure spray guns in Sources 101 and 104.
8. Emission reductions of the targeted contaminant(s) below the level specified in this approval which are achieved by optimizing the effectiveness of equipment installed pursuant to this operating permit are not surplus emission reductions, and thus, may not be used to generate Emission Reduction Credits. In order for the emission reductions to be creditable the emission reductions must satisfy the requirements of 25 Pa. Code Chapter 127, Subchapter E.
9. The RACT requirements shall be implemented as expeditious as practicable but no later than May 31, 1995.
