

This permit is subject to the following conditions:

- 1. That the source and any associated air cleaning devices are to be:
 - (a) operated in such a manner as not to cause air pollution;
 - (b) operated and maintained in a manner consistent with good operating and maintenance practices.
- 2. The facility is to be operated in accordance with the plan submitted with the application as approved herein.
- 3. See attached.

Failure to comply with the conditions placed on this permit is a violation of Section 127.25. Violation of this or any other provision of Article III of the rules and regulations of the Department of Environmental Resources will result in suspension or revocation of this permit and/or prosecution under Section 9 of the Air Pollution Control Act.

- The facility shall not exceed the 48.19 ton/yr emission limit of VOC's that was proposed in the synthetic minor permit application.
- 4. The facility shall submit quarterly reports, and cumulative totals for the year to demonstrate compliance with condition # 2. The reports (at a minimum) shall contain the VOC emissions from each source in pounds per hour and tons per year, and the hours of operation.
- 5. This operating permit applies to the emission of VOC pollutants only. Emission of other pollutants, including criteria pollutants, shall be governed by the existing Plant Approvals, Operating Permits any applicable requirements and other Rules and Regulations of the Department.
