**PERMIT CONDITIONS**

3. This operating permit incorporates Reasonably Available Control Technology (RACT) determinations as required by the provisions of Title I of the Clean Air Act Amendments and 25 Pa. Code Sections 129.91 through 129.95 for the following wood furniture finishing sources:

Booth Descriptions	Booth ID Numbers
4 spray stain booths	1, 2, 3 and 21
2 washcoat booths	5 and 22
6 sealer booths	13, 14, 15, 16, 24 and 25
3 glaze booths	4, 6 and 7
1 wiping stain booth	23
2 shade booths	8 and 9
6 lacquer booths	10, 11, 17, 18, 26 and 27
1 sample booth	12

4. Pursuant to the RACT provisions of Sections 129.91 through 129.95 of Chapter 129 of Article III of the Rules and Regulations of the Department of Environmental Protection, "reasonably available control technology" for the booths identified in condition 3 herein is the use of coatings (as mixed for application) with volatile organic compound (VOC) contents of not greater than the following:

Coating Category	VOC Content Limit
topcoats	1.8 pounds per pound solids
sealers	1.9 pounds per pound solids
washcoats	7.0 pounds per gallon coating (minus water)
all other coatings	7.0 pounds per gallon coating (minus water)

- ~~5. Pursuant to the provisions of Sections 127.206 through 127.210 of Chapter 127 of Article III of the Rules and Regulations of the Department of Environmental Protection, this operating permit is issued for the establishment of 28.45 tons of volatile organic compound emission reduction credits as a result of the permanent shutdown of the sources identified in condition 3 herein. Should the sources identified in condition 3 herein ever be reactivated at the Water Street plant, the emission reduction credits established herein shall become null and void.~~
- ~~6. Pursuant to the provisions of Section 127.206(f) of Chapter 127 of Article III of the Rules and Regulations of the Department of Environmental Protection, the emission reduction credits established herein shall expire on November 22, 2005, if said emission reduction credits are not included in a plan approval.~~

- ~~7. This operating permit is valid for a limited period of time and may be renewed before its expiration. Requests for an operating permit renewal must be in writing and must be accompanied by the appropriate permit application processing and annual permit administration fees as specified in Section 127.703 of the Rules and Regulations of the Department of Environmental Protection. These fees shall be paid in the form of a check payable to the "Commonwealth of Pennsylvania - Clean Air Fund". The request should be made using the appropriate application form and must be received by the Department along with a completed Air Pollution Control Act Compliance Review form no later than September 1, 2003.~~

~~Additional annual operating permit administration fees may also be required pursuant to Section 127.703. If required, these fees are to be paid by no later than September 30, 1999, September 30, 2000, September 30, 2001 and September 30, 2002. The administration fee is to be submitted with an Annual Operating Permit Administration Fee Transmittal form.~~
