§ 244-3.1 General CAIR NO_x Annual Trading Program permit requirements.

(a) Each CAIR NO_x source must have a permit issued by the department pursuant to Parts 201 and 621 of this Title.

(b) Each CAIR permit must contain, with regard to the CAIR NO_x source and the CAIR NO_x units at the source covered by the CAIR permit, all applicable requirements for the CAIR NO_x Annual Trading Program, the CAIR NO_x Ozone Season Trading Program, and the CAIR SO₂ Trading Program and shall be a complete and separable portion of the permit under subdivision (a) of this section.

§ 244-3.2 Submission of CAIR permit applications.

The CAIR designated representative of any CAIR NO_x Ozone Season source must submit to the department a complete CAIR permit application under section 243-3.3 of this Title for the source covering each CAIR NO_x Ozone Season unit at the source by the later of January 1, 2008 or the date on which the CAIR NO_x Ozone Season unit commences commercial operation, except as provided in Subpart 245-9.4 of this Title.

§ 244-3.3 Information requirements for CAIR permit applications.

A complete CAIR permit application must include the following elements concerning the CAIR NO_x Ozone Season source for which the application is submitted, in a format prescribed by the department:

- (a) identification of the CAIR NO_x Ozone Season source;
- (b) identification of each CAIR NO_x Ozone Season unit at the CAIR NO_x source; and
- (c) the standard requirements under section 243-1.6 of this Part.

§ 244-3.4 CAIR permit contents.

Each CAIR permit will contain, in a format prescribed by the department, all elements required for a complete CAIR permit application under section 243-3.3 of this Subpart and all applicable requirements of this Subpart.
