In accordance with Section 309(g) of the Clean Water Act (CWA), 33 U.S.C. § 1319(g), notice is hereby given that the U.S. Environmental Protection Agency (EPA) Mid-Atlantic Region, is proposing to file a Consent Agreement and Final Order (CAFO) assessing an administrative civil penalty against the Respondent named below, for an unpermitted discharge and alleged violations of its National Pollutant Discharge Elimination System (NPDES) permit.

**RESPONDENT:**

Perdue Farms, Inc.

**SUMMARY OF VIOLATIONS:** EPA Mid-Atlantic Region alleges that Perdue had an unpermitted discharge of pollutants to Waters of the United States. EPA also alleges that Perdue failed to adhere to its permit by failing to implement good housekeeping practices.

**PROPOSED CONSENT AGREEMENT AND FINAL ORDER:** Based on the foregoing and having taken into account the penalty factors set forth in Section 309(g) of the CWA, 33 U.S.C. § 1319(g), EPA Region III proposes to file the CAFO requiring the payment of a \$10,500.00 penalty. The CAFO both commences and concludes these proceedings.

**OPPORTUNITY FOR COMMENT:** Persons wishing to comment on the amount of the penalty or legal or factual basis for the proposed CAFO are invited to submit a statement to the EPA Regional Administrator, addressed to the attention of the Regional Hearing Clerk (address below), within forty (40) days of the date of this public notice. Comments received within this forty (40) day period will be considered. All comments must include the name, address, and telephone number of the writer and a concise statement of the basis for any comment and any relevant facts on which it is based.
