PUBLIC NOTICE

The U.S. Environmental Protection Agency (U.S. EPA) and Ohio Environmental Protection Agency (OEPA) invite public comments on the proposed U.S. EPA and the OEPA modified Resource Conservation and Recovery Act (RCRA) Permit to be issued separately to Aristech Chemical Corporation (Owner) and Sunoco, Inc. (R&M) (Operator) Hazardous Waste Facility located at 1019 Haverhill-Ohio Furnace Road, Haverhill, Ohio. The public comment period runs from May 2, 2006, through June 19, 2006.

The Haverhill facility generates two distinct types of hazardous waste fuels, namely light hydrocarbons (LHC) and heavy hydrocarbons (HHC) wastes. These hazardous waste fuels are burned in four (4) on-site boilers as supplemental fuel to natural gas. These boilers are operating under a RCRA permit issued by U.S. EPA on October 21, 2004, and subject to the requirements of Title 40 Code of Federal Regulations (40 CFR) Part 266, Subpart H: Hazardous Waste Burned in Boilers and Industrial Furnaces, commonly referred to the BIF Rule.

The U.S. EPA and OEPA received a Class 3 permit modification request from the Permittees on May 20, 2005, and November 30, 2005, respectively, which includes a trial burn plan. The proposed permit modification includes modification to Boiler UC for burning heavy and light hydrocarbon wastes concurrently. The modified permit will streamline waste burning and steam production from the existing hazardous waste burning boilers.
